American Economic Journal: Economic Policy

The American Economic Journal: Economic Policy, or AEJ Policy for short, published four issues in 2013.

As stated in the call for papers posted on the journal's website:

AEJ Policy will publish papers covering a range of topics, the common theme being the role of economic policy in economic outcomes. Subject areas will include public economics; urban and regional economics; public policy aspects of health, education, welfare, and political institutions; law and economics; economic regulation; and environmental and natural resource economics.

Editorial Process

AEJ Policy is a peer-reviewed journal, now following the same single-blind procedure used by the American Economic Review (AER) and the other AEJs. The submission fee is \$100 for AEA members and \$200 for nonmembers. The journal rejects some papers on the basis of an initial screening by the Editors (in which cases submission fees are returned to authors). Unlike the AER, AEJ Policy does not have separate sections of longer and shorter papers. Along with the other AEJs, we have adopted a liberal republication policy, granting authors of published papers the right to republication in any work in any form, including digital repositories. We follow the AER's policy with respect to the posting of information, requiring that authors of accepted papers that employ data in econometric exercises, simulation models, or experiments agree to post their data and programs on the journal website unless an exemption for proprietary data is requested and granted.

Submissions to the journal must be made electronically, via the journal website (www. aeaweb.org/aej-policy/), using editorial software set up for the journal by Manuscript Central. All subsequent editorial correspondence with referees and authors is also done electronically, including the provision of ultimate decision letters and referees' reports to authors. Since July 1, 2012, the journal has followed the AEA's new disclosure policy, requiring authors to provide statements with their submissions indicating sources of funding and potential conflicts of interest. A significant element of the journal's operation is coordination of the review process with the *AER*, following a common procedure worked out in consultation with the Editors of the other new journals and the *AER*. When submitting their papers via the *AEJ Policy* website, authors of manuscripts previously reviewed by the *AER* may request that, subject to the referees' agreement, the full correspondence files of the *AER* referees (including not just the referees' reports but the referees' cover letters as well) be shared with the Editors of *AEJ Policy*, who will have the discretion to make a decision based on these reports or to request additional reports.

The Editor assigns each manuscript either to himself or to one of the Coeditors, and all subsequent responsibility for handling the manuscript—including the decision of whether to reject summarily, the choice of referees, and the ultimate disposition of the paper—rests with the person to whom the paper has been assigned. The journal has adopted a policy to avoid conflicts of interest, so that papers by department colleagues, current students, or coauthors will be assigned to another member of the senior editorial team. Other members of the editorial board may, on occasion, be asked to assume responsibility for papers.

Editorial Staff

The journal's Coeditors are Mark Duggan (Wharton School, University of Pennsylvania) and Dan Silverman (Arizona State University), a former member of the editorial board who became Coeditor on July 1, 2013 replacing John Karl Scholz (University of Wisconsin, Madison), who stepped down when he became his university's Dean of the College of Letters and Science. The members of the AEJ Policy editorial board are Douglas Almond, Robin Boadway, Stephen Coate, Dhammika Dharmapala, Lucas W. Davis, William N. Evans, Robert C. Feenstra, David N. Figlio, Michael Greenstone, Louis Kaplow, Henrik Jacobsen Kleven, Christopher R. Knittel, Wojciech Kopczuk, Adriana Lleras-Muney, Deborah J. Lucas, Jens Ludwig, Erzo F. P. Luttmer, Kathleen McGarry, Cecilia Rouse, and Jonathan Skinner. During the year, Severin Borenstein, Julie Berry Cullen, Roger H. Gordon, Jonathan Gruber, Brigitte Madrian, and Thomas J. Nechyba completed their terms as members of the board, leaving with our appreciation for their service.

Board members provide valuable advice concerning journal policy, aid in the identification of suitable referees, serve as referees themselves, and have been asked on occasion to assume additional editorial responsibilities.

Editorial Data

The distribution of submissions to the journal by year (ending October 31) is shown in Table 1, indicating relatively steady growth over time. Of the 411 original submissions during the year ending October 31, 2013, one paper was withdrawn from submission prior to being reviewed. Of the remaining papers, as of November 12, 174 (42 percent) had been summarily rejected. (This summary rejection rate is lower than last year's, when it was 46 percent, but higher than in 2011, when it was 39 percent.) An additional 145 papers had been rejected after the normal refereeing process. Of the remaining papers, 33 had received an invitation to revise and resubmit, and the other 58 papers were still in the initial review process as of October 31. If one assumes that the papers still in review will be rejected or invited to revise in the same fractions as reviewed papers for which decisions have already been made, then approximately 11 percent of papers submitted this year eventually will have received positive first-round decisions, compared to 16 percent based on the same calculation last year and 20 percent the year before. This steady decline in the fraction of papers receiving a favorable first-round response primarily reflects a toughening standard being applied as the number of submissions to the journal has increased.

Notes: Submissions to the *AEJ Policy* for each year include all new submissions from November 1 of the previous year through October 31 of the stated year. Publications for 2009 include the February and August issues. Publications for for all other years include the February, May, August, and November issues.

Table 1 also shows the number of manuscripts submitted each year via transfer from the *AER*, with 39 such manuscripts in 2013.

Table 2 shows the status of manuscripts by year of submission, as of the end of each respective year.

Table 3 shows the performance of the journal with respect to the distribution of first decision times for papers submitted during the period Nov. 1, 2011–Oct. 31, 2012, and projected using Kaplan-Meier hazards for the period Nov. 1, 2012–Oct. 31, 2013. Table 3 indicates that the journal has continued to provide initial decisions on virtually all manuscripts in less than six months. The average number of days until the first decision on submitted papers (not shown in the table) was 49 days in 2013, a slight increase from the 46 days in 2012, with this increase primarily reflecting the small decline in the fraction of papers issued a summary rejection.

Table 4 shows the total publication lags for papers published during 2011, 2012, and 2013. Table 4 shows an increased lag from submission to acceptance in 2013, but only a slightly longer lag from acceptance to publication—still just under one year.

Table 5 lists the number and average page length of published papers in each year, and Table 6 lists the *JEL* classifications of these papers (with multiple categories possible). The changes in distribution between 2012 and 2013 do not indicate any marked trend, and are in line with previous year-to-year fluctuations. Table 7 lists statistics regarding our journal's data-posting policy
