REQUESTED ACTION:

Request that the Common Council move to rescind its action taken at its meeting on August 2, 2011, to direct the Plan Commission to review and make recommendations with regard to the comprehensive plan and future development for the Sections 35 and 34 areas (Neighborhoods "G" and "H", but allow Council time to hold neighborhood meetings prior to the Plan Commission taking this item up). No further action shall be taken to consider any such amendments.

FISCAL IMPACT: Undetermined

RATIONALE:

In our deliberations on August 2, 2011, I believe I made myself clear prior to discussions taking place at the Plan Commission or moving forward with any actions on changes to the Comprehensive Plan that I would need to hold neighborhood meetings. These meetings would be held with District #4 and #5 constituents for the purpose of receiving feedback on amending the City's Comprehensive Plan.

In January, 2012, four Neighborhood meeting were held to solicit input from the residents. Information/feedback was collected at all four meetings as well as communications that have been received since that time from the residents in this section of the City.

The feeling of the residents of District #4 has been overwhelming against modifying the City's Comprehensive Plan. I feel it is in the best interests of the residents of the area and the City of New Berlin to not pursue further discussion on this matter.
