

ND Century Code 15-10-18.3. states dependents of resident veterans who meet the definitions of "dependent" and "resident veteran" as defined in NDCC 15-10-18.2 are entitled to receive a 100% tuition/fee waiver upon being accepted for enrollment into any undergraduate degree or certificate program at any of the eleven North Dakota state institutions of higher education for as long as the dependent is eligible to obtain a certificate of completion or up to a bachelor's degree within a forty-five month or ten-semester period.

The following must be attached prior to any determination of eligibility and the student section below completed:

- ____ Copy of Veteran's DD214 (Report of Separation from Active Duty)
- ____ Certification from department of veterans' affairs indicating veteran was killed in action or died from wounds or other service-connected causes, has a one hundred percent service –connected disability or as determined by the department of veteran's affairs, has an extra-schedular rating to one hundred percent as determined by the department of veterans' affairs, died from service connected disabilities, was a prisoner of war, or was declared missing in action.
If the veteran is deceased, verification must be provided that the child's other parent has been a resident of this state and was a resident of this state at the time of death or determination of total disability of the veteran. Or, if the child's other parent has established residency in North Dakota and maintains residency for a period of five years immediately preceding the child's or stepchild's enrollment at an NDUS Institution.
- ____ Documentation verifying student is a "Dependent" of the Veteran, such as Federal Tax Form (1st page) or a letter from VA. (Other documentation may be required verifying the relationship of student to veteran.)
