### Summary

Roseman University of Health Sciences, College of Nursing (CON) is seeking an adjunct clinical nursing faculty who is a registered nurse. The adjunct faculty will be responsible for but not limited to, the clinical education of nursing students within health care environment.

### Responsibilities

- Consults with nursing faculty in developing clinical learning activities in conformity with outcome of the nursing program and accreditation standards.
- Facilitates discussions about accepted methods of nursing practice.
- Interacts and collaborates with nursing service personnel to facilitate optimum learning experiences for students.
- Assigns students to patients and observes performance in actual nursing situations.
- Evaluates student performance and maintains necessary records of students' progress.
- Assists students through observational and participative experiences to apply nursing theory, the nursing process and nursing techniques in clinical settings.
- Counsels students on clinical performance, facilitates problem solving processes, and offers guidance and assistance as needed.
- Makes recommendations to nursing faculty in developing curriculum content and improved teaching and nursing techniques.
- Assists in the preparation of reports required by national and state accrediting agencies, as needed.
- Performs related work as required.

### Minimum Qualifications

- Master's degree in nursing from an ACEN or CCNE-accredited institution.
- Registered Nurse in the state of Nevada or is eligible for licensure.
- Master's degree in nursing with two years' experience in clinical specialty

### Work Conditions

- Work is primarily indoors, but requires the incumbent to be in an outdoor environment when traveling between campus buildings, off campus, and to Roseman University campuses and facilities located outside Henderson, NV.
- Performing duties and attending events outside the normally scheduled work hours (evening and weekend) occasionally occurs and is required.
- Traveling off-campus to a local, state, regional and/or national event, as well as travel to other Roseman University campuses or facilities occurs occasionally and is required.

- Incumbent may be exposed to frequent noise caused by telephones, office machines, and nearby oral communications among university personnel and/or students.
- Any additional area-specific requirements.

**Required Physical Abilities**

- Ability to bend, stoop, reach, stand, move from one area of the building to another on a regular basis, sit and use a computer for a long period of time.
- Manual and physical dexterity needed to operate a computer keyboard and handle paper documents.
