

Instructions: How to Apply to Berkeley Math Circle Elementary 2012-2013

BERKELEY MATH CIRCLE > This application is ONLY for BMC-Elementary level $(1^{st} - 4^{th} \text{ grades})$.

I. For which BMC Elementary class should we sign up?

BMC Elementary is offered at two levels: Level I (grades 1 and 2) and Level II (grades 3 and 4). In 2011-2012 classes are offered at 5pm, 6pm, and 7pm. Class times and locations for 2012-2013 will be finalized in late August – early September of 2012.

II. What forms do we need to submit?

Three forms included in the body of this application packet (pages 3,4,5,6) must be filled out and mailed along with the class payment:

- 1. Application Form
- 2. Parent consent Form
- 3. <u>Photo Release Form</u>

Staple together the forms in the above order. Do NOT staple the check to the forms.

III. Can we include siblings on the same form and check?

No. For every student, you must include a separate application form, and a separate check.

IV. How do we pay for BMC-Elementary?

Class fee for 2012-2013 is \$150 per semester (fall or spring). The check must be filled out as follows:

- Pay to the order of: The Art of Problem Solving Foundation
- Memo: *BMC* Elementary [Student Name], e.g., "BMC Elementary, John Doe".

You *MUST* have the wording on your check precisely as it is written above, otherwise AoPS will reject your check. This will delay your application, and you will have to write another check. We <u>cannot</u> return incorrectly written checks to you; they will be automatically shredded by BMC staff. The tuition for the class is considered to be a donation to math circles. Thus, once your check has been deposited, it cannot be refunded.

<u>To the parents of new students</u>: Please date your check "Sept. 1, 2012". Once a space becomes available, we will notify you via e-mail. We will NOT deposit your check until after the first class. If you choose not to continue with the class, you MUST let us know at the end of the first

lesson. If we do not hear from you, we assume that your child continues the class. NO refunds will be made after the first class.

To the parents of the students who are not offered a spot in the class: We will not be able to return your check; it will be destroyed.

V. Where do we send applications for BMC Elementary?

Staple all three pages together (do not staple your check!) and mail the complete application form and the check to:

VI. How do we know if we are accepted into the program?

Every student must submit a complete application packet and a check for \$150 by the deadline posted on our website.

- We will re-enroll all current BMC Elementary students who have submitted complete application packets and checks on time. On-going students who apply after the deadline are NOT guaranteed re-enrollment.
- New BMC students who have submitted the application packet by the deadline will be accepted into the program as space becomes available. If a student has been accepted, we will notify you via email.
- <u>To the parents of new students</u>: We will NOT deposit your check until after the first class. If you choose not to continue with the class, you MUST let us know at the end of the first lesson. If we do not hear from you, we assume that your child continues the program. NO refunds will be made after the first class.
- <u>To the parents of the students who are not offered a spot in the class:</u> We will not able to return your check; it will be destroyed.
