

Horizon Power Electrical Contractor's Information Guidelines

July 2013

INTRODUCTION

This document is to assist you in completing Preliminary & Completion notices for existing and new connections.

Please be aware of the following *Electrical (Licensing) Regulations and requirements of the Network Operator.*

- It is a requirement of the Electricity (Licensing) Regulations, Regulations 51 and 52 that an electrical contractor who carries out any notifiable work, or causes any notifiable work to be carried out, must deliver to the network operator, within the specified time, a **duly completed Preliminary Notice and Notice of Completion**.
- Failure to deliver a duly completed notice to the network operator may result in the electrical contractor receiving an Infringement Notice or becoming subject of a Breach of Licensing Regulations

Any non compliant notice(s) will be returned for completion along with information as to what is required to ensure the notice is compliant.

NEW CONNECTIONS

Back ground information

New Connections begin with a customer/customer representative setting up an account with Horizon Power by calling either the Residential 1800 267 926 or Business 1800 737 036 numbers.

Please be aware that customers are required to establish separate accounts for temporary and permanent supplies.

What you need to do

Preliminary notice(s) must be sent to the Horizon Power Connections Team prior to work commencing.

Completion notice(s) must be sent no later than **three** days after the work has been completed.

They can be submitted via

- Fax 6310 1044, or
- Email <u>electricalnotices@horizonpower.com.au</u>.

What we will do

Details from both the preliminary and completion notices will be entered into Horizon Power's meter billing system. A job will be issued to our crews to attend site.

We allow 3-5 business days to issue the job once the compliant notice has been accepted.

Please note that a Network Service Request (NSR) is required for all new connections.

EXISTING CONNECTIONS

Background

Existing Connections include overhead to underground connections, disconnection/reconnection, meter relocation, board upgrades etc.

What you need to do

If completing any of the above listed work you are required to submit a preliminary and completion notice to Horizon Power Connections Team via

- Fax 6310 1044, or
- Email <u>electricalnotices@horizonpower.com.au</u>.

If you require Horizon Power's attendance please state this on the preliminary notice, e.g. a disconnection or reconnection is required.

Please note the completion notice must be provided within **three** days of the work been completed.

What we will do

A job will be issued to our crews for them to attend the site once the compliant preliminary notice has been processed. We allow 3-5 business days to issue the job once the compliant notice has been accepted.

Please note that a Network Service Request (NSR) is required for all existing connections requiring crew attendance.

Please see below examples of completed Network Service Requests for temporary supplies, upgrades, mains connection, disconnection, reconnection, demolition and or supply abolishment.



The following highlighted areas are mandatory for: - Temporary Supply - Upgrades, or - A Mains Connection.

- Network Operator (always Horizon Power)

On New Connection notices the Installation Number/reference number must be included. This is an 8 digit number e.g. 10200009.

On Existing Connection notice the Meter Number must be included.

If you are submitting;

- a Design and Quotation Acceptance (DQA) please include the Quote Number of Work Request number you were given by the Depot.
- Notices for transportables please provide a skid or chassis number and final destination if possible.

Please note that if you are working on multiple units you must submit individual notices for each unit. If it is a New Connection the Customer will need to contact **Horizon Power on 1800 267 926** to be issued with the correct Installation Numbers. For existing connections please include the meter number on site.

- Advise of the work being carried out including RCD installations, smoke alarm, upgrade of wiring etc in the comments field.

*A Network Service Request (NSR) form needs to be completed for any job that requires a Horizon Power crew to attend the site and carry out works. The preliminary/completion notice will not be processed or connected without a NSR.

Exemptions from submitting a NSR are when the works are covered under a project number which has been set up as a Design and Quotation Acceptance (DQA). For example large projects (CT meter, HV CT meter) etc.

Please ensure that:

- All fields are completed on the NSR. If the information does not match your notices, is incorrect or is missing it will be returned for completion.
- A meter number is included if it is an existing property or if you require a supply abolishment.
- The preliminary/completion notice number **must** be provided, except for a supply abolishment.
