NOTICE OF ABATEMENT OF SUBSTANDARD STRUCTURES

Notice is hereby given that the Board of Aldermen of the Village of Lake Tanglewood, Texas, in a Public Hearing on November 9, 2015, received and considered a report from the Village Inspector and Professional Engineer indicating that structures on the following property are substandard and warrant abatement pursuant to the terms of Section 8.03.001 of the Code of Ordinances of the Village of Lake Tanglewood, Texas. Upon receipt of such report and after consideration of same, the Board of Aldermen declared the structures a nuisance, and ordered that the nuisance be abated within 60 days by either repair or demolition of the structures on the property, and that if the nuisance is not abated within 60 days, then the City will proceed with demolition and removal of all the structures on the lot.

If the City abates the nuisance, then all of the structures on the property will be demolished at the expense of the City. In the event the owner fails to pay the expenses within 30 days of the invoice, the Village of Lake Tanglewood will file a lien against the property for reasonable costs of demolition and removal of the structures. A copy of this notice can be obtained at the Village of Lake Tanglewood Office, 100 N. Shore, Amarillo, TX 79118-9430.



FICTION

THE MAGIC STRINGS OF FRANKIE PRESTO, by Mitch Albom. Frankie Presto, a war orphan raised by a blind music teacher, is the greatest guitar player ever to walk the earth. His journey weaves through the musical landscape of the 20th century, affecting stars such as Hank Williams and Carole Kingalong the way. But his gift is his burden: through his music, he can affect people's futures.

THE GUILTY, by David Baldacci. Will Robie is the government's best, and most lethal, assassin. He had severed all ties with his past – until his father, a respected attorney in a small, Mississippi Gulf Coast town, is accused of murder. Ignoring his father's wishes, Will begins a desperate investigation into the case. Fourth in the series.

THE CROSSING, by Michael Connelly. Retired LAPD detective Harry Bosch's half-brother, attorney Mickey Haller, needs his help. He is sure the murder rap against his client is a setup. Against his instincts, Bosch takes the case, and with help from his former LAPD partner Lucia Soto, he turns the investigation inside the police department. And makes himself a target. 20th in the Harry Bosch series; sixth in the Mickey Haller series.

CAREER OF EVIL, by Robert Galbraith. A package containing a severed leg is delivered to Robin Ellacott. Her boss, private detective Cormoran Strike, thinks there are four people from his past who could be responsible – and each is capable of unspeakable brutality. He and Robin delve into the dark and twisted worlds of the suspects, as time runs out for the two of them. Third in the series.

AVENUE OF MYSTERIES, by John Irving. Born and raised in Mexico, Juan Diego had a sister, Lupe, who thought she could see the future coming. What might a 13-year-old girl be driven to do if she thought she could change that future? As an older man, Juan Diego travels to the Philippines. There, what happened to him in the past – in Mexico – collides with his future.

THE THEORY OF DEATH, by Faye Kellerman. Now with the Greenbury, Connecticut, police force, Peter Decker's peace is shattered when a body is found in the woods. The investigation leads to a sphere of scheming academics, hidden cyphers, and harmless nerds-turned-calculating, evil geniuses at the nearby college. 22nd in the series featuring Peter Decker and Rina Lazarus.

YOU, by Caroline Kepnes. Beck doesn't know it yet, but she is perfect for Joe, and he seems custom-made for her. But there's more to Joe than Beck realizes, and much more to Beck than her oh-so-perfect facade. Their mutual obsession quickly spirals into a whirlwind of deadly consequences.

MURDER ON ST. NICHOLAS AVENUE, by Victoria Thompson. Detective Sergeant Frank Malloy and Sarah Brandt are not the only ones who have recently tied the knot. Family friend Mrs. O'Neill was delighted when her daughter Una wed the seemingly wealthy and charming Randolph Pollock. She didn't wonder why such an affluent man would want to marry a poor Irish girl, no matter how pretty she was. But now Mrs. O'Neill has a problem. A Gaslight Mystery.

THE STORIED LIFE OF A.J. FIKRY, by Gabrielle Zevin. With his wife gone, a rare book stolen, and both his bookstoravee and love of life in serious decline, only something extraordinary could alter the sagging fortunes of A.J. Fikry and Island Books. What he discovers one night among the children's books, however, could change everything. "A love letter to books and the culture around them."

NON FICTION

I SHOULD BE DEAD, by Bob Beckel. Growing up poor in an abusive home, Bob Beckel learned to be a survivor: to avoid conflict, mask his feelings, and to lie--all skills that served him well in Washington, where he would become the youngest-ever Deputy Assistant Secretary of State and manage Walter Mondale's 1984 presidential campaign. But Beckel was living a double life. On January 20, 2001--George W. Bush's first Inauguration Day--he hit rock bottom, waking up in the psych ward. Written with captivating honesty, Beckel chronicles how his addictions nearly killed him until he found help in an unexpected ally, conservative Cal Thomas, who helped him find faith, get sober, and get his life back on track.

AGENTS OF BABYLON, by Dr. David Jeremiah. This book examines prophecy through the eyes of the characters in the book of Daniel, explains what the prophecies mean, and helps us understand how these prophetic visions and dreams apply to our lives today.

THE WITCHES – SALEM 1692, by Stacy Schiff. It began in the raw Massachusetts winter of 1692, when a minister's daughter began to scream and convulse. It ended less than a year later, but not before 19 men and women had been hanged and an elderly man crushed to death. The panic spread quickly as neighbors accused neighbors, parents and children each other. In curious ways, the trials would shape the future republic.
