### Update by the President

Governor Nathan Deal recommended in the budget that he sent to the General Assembly an increase in funding to allow the Archives to be open five days a week. His recommendation is now being considered by the members of the legislature. Assuming that this item in the governor's budget is approved, the Archives will be open from Tuesday through Saturday sometime later this year. Special thanks to Dianne Cannestra, whose term as President and member of the FOGAH board has ended. Her leadership has been critical in efforts to restore funding to the Archives.

I had the honor of presenting plaques on behalf of FOGAH to Senator Jack Hill and Representative Terry England, chairs of the legislative appropriations committees, for their support of the Georgia Archives.

## Welcome new FOGAH Board members



**Dr. LeeAnn Lands**—Dr. Lands is Associate Professor of History and American studies in the Department of History & Philosophy at Kennesaw State University, with degrees from The University of Florida and Florida Atlantic University, and a Ph.D., from the School of History, Technology, and Society at Georgia Tech. Her research and teaching interests are 20<sup>th</sup> century U.S. urban history and urban geography, particularly housing and anti-poverty movements and housing segregation. She is an award-winning author and scholar. Recent honors include the KSU Foundation Distinguished Service Award (for 2011) and the KSU Foundation Prize for Publication (2010) for her book *The Culture of Property: Race, Class and Housing Landscapes in Atlanta, 1880-1950.* She is a member of several professional organizations including the Association of American Geographers. She resides in Atlanta, and was elected for a three-year term on the FOGAH Board.

**Dr. David B. Parker**—Dr. Parker is Professor of History and Assistant Chair, in the Department of History & Philosophy at Kennesaw State University. He is a native of North Carolina with degrees from Duke University and the University of North Carolina, Chapel Hill.

He is a prolific author and speaker whose most recent book is *Breaking the Heartland: The Civil War in Georgia*, a book of essays co-edited with John Fowler and published by Mercer University Press. He has also written on the carpet industry, evangelist Sam Jones, Rebecca Felton, *The Wonderful Wizard of Oz*, and Bill Arp, among other interesting topics.

Dr. Parker resides in Acworth. He was elected for a three-year term on the Board of Trustees.





**Sarah Quigley**—Ms. Quigley is a Certified Archivist who currently works as a Manuscript Archivist at Emory University in Atlanta. Her degrees from the University of Texas at Austin are in Information Studies and History with a Minor in American Studies. She holds membership in the Academy of Certified Archivists, The Society of American Archivists and the Society of Georgia Archivists. She recently co-curated the exhibition "And the Struggle Continues: The Southern Christian Leadership Conference's Fight for Social Justice" at the Robert W. Woodruff Library at Emory University. She is a frequent presenter and author of a number of publications, including a forthcoming article in *Provenance* entitled "Evolving Advocacy: The Society of Georgia Archivists and the Georgia Archives Budget Crisis." She resides in Decatur and was elected for a three-year term as a Trustee.

John Sheftall—A native of Macon, GA, Mr. Sheftall received his B.A. in History from the University of Georgia and his M.A. and J.D from the University of Virginia. He is a partner at the Columbus, GA, law firm of Hatcher, Stubbs, Land, Hollis & Rothschild, with a focus on estate planning, estate administration and fiduciary litigation. He is a Fellow of the American College of Trust and Estates Counsel and has served on the boards of Sun Trust Bank, West Georgia and St. Francis Hospital Foundation.

Mr. Sheftall's avocation is history, and he has been involved in leadership positions in a number of organizations promoting historic preservation, including the Georgia Historical Society, the Georgia Trust for Historic Preservation, and Historic Columbus Foundation. He is the author of several books and a number of articles on Georgia history.

He and his children are the seventh and eighth generations to live at their ancestral home, The Cedars. He was elected for a three-year term.

Kenneth H. Thomas, Jr., presented *Changes in Genealogy Help Us Find the Same Old Ancestors*, sponsored by Friends of Georgia Archives & History.

## Georgia Archives Month 2013

Governor Nathan Deal signed a proclamation declaring October as Georgia Archives Month. Included among those on hand for the signing were several staff members of the Georgia Archives, FOGAH members, and individuals from other organizations in support of the Archives.

## Georgia Historical Records Advisory Council 2013 Awards Program

The Georgia Historical Records Advisory Council (GHRAC) was originally created in 1993 by the General Assembly as the Georgia Historical Records Advisory Board. The Council has 12 members appointed by the Governor and represents educators, historical organizations, professional organizations, and citizens.

GHRAC works to ensure that Georgians are made aware of historical records statewide, enhances the preservation and care of these records, and strives to improve public access to the records.

In an effort to promote the educational and historic use of Georgia's documentary heritage, GHRAC sponsors an annual program which recognizes outstanding efforts in archives and records work. Awards are presented in various categories such as historical research, use of archives, documenting Georgia's history, legislative work, and advocacy. Winners are recognized at the awards program held at the Georgia Archives each year. During the October 2013 program, an award for Advocacy was presented to FOGAH and the Coalition to Preserve the Georgia Archives. In recent years Georgians were faced with the possibility that our state Archives might be closed to the public. FOGAH and the Coalition, an ad hoc partnership of individuals and organizations who came together to support and advocate for the Archives, emerged to organize, energize and enlist thousands of professionals and lay citizens who rose up in protest.

The groups experienced their first success when Governor Deal announced emergency funding to keep the Archives open two days per week, as well as his intention to seek legislative approval to transfer the Archives to the University System of Georgia. FOGAH contracted with a consulting firm to direct efforts of supporters of the Archives. Thousands of supporters contacted their state representatives and senators, as well as a number of media outlets.

On May 6, 2013, members of

FOGAH and the Coalition, along with representatives of several partner organizations, were present when Governor Deal signed into law HB 287 (Act 184) which transferred the Georgia Archives to the University System of Georgia.

The award was presented by Steve Wrigley, Executive Vice Chancellor of Administration, University System of Georgia. Dianne Cannestra and Tim Crimmins accepted the award on behalf of FOGAH, and Kaye Minchew accepted on behalf of the Coalition.

Two of the award categories include Excellence in Student Research Using Historical Records, Grades 9-12 and Grades 6-8. These are the youngest award winners in the program. FOGAH recognized these middle and high school students with a cash award of \$100.00 each. The 2013 winners are high school student Christine Yin and middle school student Nathan Wright, pictured below accepting their award from GHRAC and cash prize from FOGAH.
