- **4.1** Parks Committee: Member Harrison said the main discussion of the recent meeting focused upon the final wording for the Phase II Monuments in the Veterans Park. Leahnette said the wording for five out of six monuments was finalized, and final adjustments are currently being made to the Coast Guard wording.
- **4.2** <u>Water and Sewer Committee:</u> Micah said the leak detection work is scheduled to start on Monday, December 15, and should continue throughout the week, and then the Public Works crew will focus on repairing leaks that are identified.

Leahnette said the City will be filing a claim against NW Kodiak Construction's performance bond because they have failed to complete the work. Micah estimated that the project is about 90% complete.

- **4.3** Street Committee: Micah said the Public Works crew is working on some storm drainage improvements, and will schedule the striping and crack sealing work when the weather permits.
