For over 37 years, MassCOSH has forged relationships with workers and organized labor to ensure that workers know their legal rights and have ready access to skilled legal representation when the law has been broken.

Every year, MassCOSH referrals result in hundreds of thousands of dollars returned to workers. Yet, despite our impressive efforts, we feel we are just scratching the surface of matching workers with legal council and we need your help.

This directory is intended to be distributed to union partners and workers who would like to seek out legal counsel. The funds generated by its proceeds will help MassCOSH manage its ever increasing load of workers seeking aid as well as help pass legislation that benefits all workers such as H2460 (an expansion of OSH protections) and H1698, SB866 (increased burial benefits under Workers' Compensation).

The many benefits of taking part in MassCOSH's annual Legal Access Attorney Directory include:

- Exposure to organized labor as MassCOSH distributes the book to its union members
- Directory availability during Worker Memorial Day events honoring workers killed on the job and aiding those affected by workplace illness, injury and death

In a notable 2013 MassCOSH victory, MassCOSH lawyers' committee member Brian Joyce won a major settlement from Walmart on behalf of the family of Romulo Santos, a Brazilian-born worker who was electrocuted on a construction site in 2008.

While the funds won't bring Santos back to his family, it will both help them as they struggle financially with the loss of an important breadwinner and will send a message to Walmart that the company needs to take responsibility for the safety of their construction projects and of workers within their stores.

(The exact amount can't be disclosed due to a confidentiality clause in the settlement.)

Agreement Between MassCOSH And 2014 Attorney Directory Participants

In addition to participating in MassCOSH's 2013-2014 Attorney Directory, I/we agree to the following:

<u>Responsiveness</u> – Following an inquiry by MassCOSH or a worker, participating attorneys will contact the worker within 48 hours to schedule an intake. Within ten days of receipt of proper materials needed to evaluate the case, the attorney will provide the client with either an agreement to represent or written notice that s/he is unable to take the case.

<u>Orientation</u> – Either upon accepting the case or in the initial meeting with the client, the attorney will orient the worker about what s/he can expect from the workers compensation process and approximate time lines.

<u>Communication Frequency</u>: The attorney will inform the worker as to the preferred method of communication (writing and/or phone) and the regularity with which s/he can expect updates.

<u>Communication Language</u>: It is expected that the attorney will provide translation for non-English speaking clients at all meetings, as well as written communication to ensure that the worker is fully informed of the process.

<u>Respect</u> – It is expected that, if presenting a settlement offer, the attorney will be respectful of the worker's wishes and not put undue pressure on the worker. Any written or verbal communication about the settlement is expected to be translated.
