Thank you for your interest in becoming a member of the University of Cincinnati's Student Government. Whether you are running for the position of President/Vice President or At-Large Senator, this is an exciting time to be a part of Student Government. We are thrilled at your interest in representing over 30,000 undergraduate students.

This packet contains many important documents that will be necessary for you to be included in the February elections. You will find enclosed the Schedule of Events, Grade Release Form, the Judicial Consent Form, the Elections Agreement Form, a copy of the 2013 Election Rules, a Petition Form, and the Campaign Worker Registration form. Please look through the packet, and familiarize yourself with the 2013 Election Rules. Not included in this packet is the Electronic Petition for Candidacy Form, which is located on the Student Government website at [www.uc.edu/sg/election](http://www.uc.edu/sg/election).

This packet must be completed and returned to the Student Government office by February 4, 2013, at 5:00pm. If the packet is not turned in by 5:00pm, an exception has not been granted, or the packet is incomplete you will be disqualified and will not be placed on the February ballot. When you return your completed packet, please reserve a place at the mandatory Candidate Orientation. All candidates and slates are required to attend an orientation and failure to do so is grounds for disqualification.

Please remember that all At-Large Candidates are required to collect 100 signatures and all Executive Slates are required to collect 250 signatures from registered undergraduate students of the University of Cincinnati. Collecting signatures beyond the required number can help to ensure that your packet is not declared invalid; additional spaces have been provided for this purpose.

This year we are asking that all At-Large Candidates and all Executive Slates send in a photo to be used for blackboard voting along with the attached documents. While this is not mandatory, it is highly encouraged.

If you have any questions please do not hesitate to contact a member of the Election Facilitation Committee (EFC). We look forward to working with you in the coming months!
