NOW, THEREFORE BE IT RESOLVED, by the Mayor and the Borough Council of the Borough of Gibbsboro in the County of Camden of the State of New Jersey, that we do hereby officially designate the Environmental Commission as the Borough of Gibbsboro's Green Team and hereby authorize the Environmental Commission to form a Sustainability Subcommittee inviting additional members to participate for the Sustainable Jersey Program and for the purposes of applying for Sustainable Jersey grants.

BE IT FURTHER RESOLVED that the Green Team as created by the within Resolution shall be advisory in nature and shall not have the authority to bind the Borough of Gibbsboro without further action by the Mayor and the Borough Council.

BE IT FURTHER RESOLVED that the Green Team shall periodically report and make recommendations to the Mayor and Borough Council of its activities and recommended actions to be taken by the Borough.
