Asbestos waste must be packaged in 6 mil polyethylene bags or provide a 6 mil polyethylene tarp of sufficient size to cover the entire load once it is deposited in the landfill. It is your responsibility to repackage any asbestos waste container that is broken, punctured or leaking during unloading. You are responsible for the health and safety of your driver. Ensure your driver has a shovel, broom, wetting agent, PPE and spare bags in the vehicle as required by O. Reg. 347.
