Buyer acknowledges that Buyer has not received or relied upon any oral or written statements regarding the well(s) made by Seller or any real estate licensee not expressly contained in the Real Estate Sale Agreement or this Addendum. Buyer should secure expert advice. Your real estate licensee is not an expert in well water quality or quantity.

Buyer and Seller shall use their best efforts to obtain the required or elected tests, inspections or reports in a timely manner and shall

promptly submit the results of such tests, inspections or reports to the other party. Completed tests, inspections or reports shall be
