My participation in these activities is purely voluntary and I choose to participate in spite of and with knowledge of the risks. Therefore, I, and my parent(s), if I am a minor, assume and accept full responsibility for myself, for those risks identified here and for those risks not identified, including but not limited to death, bodily or personal injury, property damage or loss, expenses, or other loss suffered by myself and them, resulting from those risks and from my own negligence.
