Your photos will be enhanced & edited to your satisfaction. Your edited & numbered proofs, typically 35 - 40 images, will be emailed to you in a album for your proofing. Additional prints may be ordered separately. Please allow 2 weeks for delivery.

_____ Gold Bridal Portrait Package \$300

- CD with 10 edited images (Can print up to size 8 x 10)

Your photos will be enhanced & edited to your satisfaction. Your edited & numbered proofs, typically 40 - 45 images, will be emailed to you in album for your proofing. Additional prints may be ordered separately. Please allow 2 weeks for delivery. A CD of ALL of your images can be purchased for \$140 with this package.

_____ Platinum Bridal Portrait Package \$420

- Up to 1.5 hour(s) photo session
- CD with ALL images (Can print up to size 8 x 10)
- (1) 16 x 20 print
- 1 Digital image will be emailed or added to your CD in high resolution for announcement submission.

Your photos will be enhanced & edited to your satisfaction. Your edited & numbered proofs, typically 50 - 55 images, will be emailed to you in a private album with password for your proofing. Additional prints may be ordered separately. Please allow 2 weeks for delivery.

- Wedding - (Retainer Fee Required)

My goal is to document each priceless moment of your wedding day with great focus on the details of the wedding preparation, ceremony, reception and any before and after special customs. Emotions speak louder than words and I strive to capture them in an artistic fashion. I combine photojournalism with formal and traditional photography. I'll tell the story of your wedding day in my photography. During the formal picture times, we will stage lots of fun and artistic poses of bride and groom, wedding party and family members at 1 or different locations of the wedding venue. The rest of the time, I will be looking for opportunities to capture candid moments during the ceremony and reception.

Each package includes my time as a photographer plus editing of all photographs. (Which includes cropping, removal of pimples, unwanted blemishes, etc. at request if unnoticed) The couple will have rights to the digital photographs if a DVD is purchased of your day. For my portfolio, I will post photographs on a web album unless requested otherwise for the respect and privacy of my clients. If you do not agree to have them posted, please initial here. _____

A link of the album with a private password will be provided for you and for family and friends of the bride and groom to view and order their favorite moments. Please allow up to 6 weeks (business days) for your link with your album to be delivered to you after your wedding day. Due to hundreds of images taken of your day, time is needed to edit and filter through them.

_____ Wedding Day Package 1 \$600

- Coverage of up to 3.5 hours
- 8.75 x 11 Photo Book Album with 20 pages (\$3.00 each additional page)
- (15) 4x6 prints
- (4) 5x7 prints
- (1) 11 x 14 print

Additional prints may be ordered separately. A \$150 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4-6 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password. For \$150 you can purchase a CD with ALL photos.

_____ Wedding Day Package 2 \$900

- Coverage of up to 4.5 hours
- CD with ALL of your favorite images and copyrights of your special day. (Can print up to 8 x 10 sizes only) All other sizes must be ordered.

If additional hours are needed & you are interested in this package, you may add \$100 per hour to this package. Prints may be ordered separately. A \$250 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4-6 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password.

_____ Wedding Day Package 3 \$1400

- Coverage of up to 6 hours
- 8.75 x 11 Photo Book Album with 20 pages (\$3.00 each additional page)
- (20) 4x6 prints

Additional prints may be ordered separately. A \$250 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4-6 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password. For \$250 extra with this package you also can purchase a CD with ALL photos with digital copyrights if added to your package)

Additional prints may be ordered separately. A \$250 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4-6 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password. For \$200 extra with this package you also can purchase a CD with ALL photos with digital copyrights if in addition to your package)

_____ Wedding Day Package 5 \$2000

- Coverage of up to 7 hours
- CD with ALL images (Can print up to 8 x 10 sizes)
- (1) 16 x 20 art canvas print

Additional prints may be ordered separately. A \$250 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4-6 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password.

_____ Wedding Day Package All Inclusive \$2100

- Up to 1 hour Engagement session

- CD with 20 of your favorite images of your Engagement session. Can print up to sizes 8 x 10. All other sizes must be ordered.
- Up to 1 hour Bridal session
- (1) 16 x 20 Bridal print
- CD with 20 of your favorite images of your Bridal Session. Can print up to sizes 8 x 10. All other sizes must be ordered.
- Coverage of up to 6 hours on Wedding Day
- 8.75 x 11 Photo Book Album with 50 pages - Up to 100 photos (\$3.00 each additional page) Timelined from your Wedding Day

- (5) 5x7 prints
- (1) 11 x 14 print

Additional prints may be ordered separately. A \$450 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4-6 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password. Your Engagement & Bridal Portraits will be available to preview up to 2 weeks. For \$250 extra with this package you also can purchase a CD with ALL photos from your wedding only with digital copyrights.

_____ Wedding Day Package 6 \$2400

- Coverage of up to 7 hours
- 8.75 x 11 Photo Book Album with up to 50 pages (\$3.00 each additional page)
- CD with ALL images (Can print up to 8 x 10 sizes)
- (1) 11 x 14 art canvas wrap
- (1) 16 x 20 print

Additional prints may be ordered separately. A \$250 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4-6 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password.

* I understand each wedding is unique. If none of these packages are what you need please let me know. A package can be tailored to fit your individual needs. If you need more hours added to your day, you will be responsible for paying the \$100 each hour before leaving the ceremony / reception. A travel fee of \$30 per hour is also required for any wedding outside Victoria County. A room / board fee of \$100 will also be added for room & board and lunch for weddings out of town.

- Terms -

AGREEMENT Overview: This Agreement expresses the full and complete agreement between the named parties and Captured Moments by Christine regarding the subject matter hereof. It supersedes all prior agreements. The only way to add or change this agreement is to do so in writing, signed by all parties.

COOPERATION: Unless otherwise noted, Captured Moments by Christine, Christine Bazan will be the exclusive photographer at this event. CLIENT agrees that guests may not take photos of the assigned photographer(s) setups, poses or arrangements without prior permission of the photographer(s). The Parties agree that good faith cooperation and communication between them is important in obtaining a good result. Captured Moments by Christine recommends that CLIENT identify to the photographer(s) important individuals during the event and during associated portraits, if they wish to have them photographed. Captured Moments by Christine or the photographer(s) will not be held accountable for not photographing desired guests if there is no one to assist in identifying and gathering people for photographs. Captured Moments by Christine is not responsible if key individuals fail to appear or cooperate during photography, or for missed images due to details not revealed to Captured Moments by Christine or beyond the photographer(s) control.

HOUSE RULES: CLIENT agrees and understands that the photographer(s) are limited by the guidelines of the ceremony official or reception site/venue management and CLIENT agrees to accept the results that may occur from said guidelines. Negotiation with the officials for moderation of guidelines is solely the CLIENTs responsibility. Captured Moments by Christine will however offer technical recommendations concerning such guidelines. Captured Moments by Christine does not guaranteed satisfaction of photos and is not liable for the unsatisfactory of the client. The photographer has 30 days to cancel with client for any emergency reasoning with the intent to refund the deposit and any payments made.

IMAGES and COPYRIGHTS: Photographs/images produced by Captured Moments by Christine are protected by Federal Copyright Law (all rights reserved). Upon final payment by CLIENT, CLIENT is granted limited license to use and display resulting images for personal use. Said images may not be altered or reproduced in any manner without prior written permission of Captured Moments by Christine. This excepting CLIENTS who receive a high resolution digital disk with printing rights, who may make prints for personal use, as indicated on disk label, but may not copy, or re distribute the disk in any manner. The CLIENT must obtain written permission from, and compensate Captured Moments by Christine prior to the CLIENT, its associates, friends or relatives publishing or selling the photographs.

MODEL RELEASE. The CLIENT hereby grants Captured Moments by Christine and successors, heirs, executors, administrators, assigns, attorneys, representatives and agents, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising or any other purpose and in any manner or medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases Captured Moments by Christine and all associates representatives and assigns from any and all claims, actions, demands, suits, liabilities, damages, expenses, and obligations of any kind arising from, or related in any manner to Captured Moments by Christine's use if said images.

RETAINER & PAYMENT SCHEDULE: \$150 / \$250 (depending on the package chosen) is due at the signing this agreement. This is a NON-REFUNDABLE RETAINER. Should CLIENT cancel or otherwise breach this Agreement, the NON-REFUNDABLE RETAINER shall be liquidated for damages of company time. If a retainer fee is not paid, Captured Moments by Christine has the right to give your wedding date to the next party of interest. The CLIENT shall also be responsible for payment of any materials/charges incurred up to time of cancellation. Otherwise, the retainer shall be applied towards the Final Total, with the remainder of charges payable in full, **two weeks prior to the date of the event.** Other arrangements may be made prior if needed.

LIMIT OF LIABILITY: In the unlikely event that the photographer(s) are injured, become too ill, or has an emergency that prevents them from photographing the event, Captured Moments by Christine will make every effort to secure a replacement photographer. If a suitable replacement is not found, CLIENT agrees that responsibility and liability of Captured Moments by Christine to the CLIENT is limited to the return of all payments received for the event. Captured Moments by Christine takes the utmost care with respect to exposure, storage, and processing the photographs/images, but cannot and does not, guarantee that photographs/images of the event will not be lost, stolen, or destroyed for reasons within or beyond our control. CLIENT agrees that Captured Moments by Christine or the photographer(s) full and complete responsibility and liability is limited to the return of all payments received for the event. CLIENT further agrees that the limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the estimated percentage of the total number of original images. The photographer does not guarantee their services or the happiness of your photos but will work with the client to try and exceed their happiness.

COMPLETION SCHEDULE: Images are **expected to be prepared for proofing within 4 – 6 weeks of the event date.** A link for proofing will be emailed to the client for proofing. A CD/DVD creation is expected within 6 weeks. Printed items and albums may require additional time.

ALBUMS: Album images are chosen by Captured Moments by Christine. Once designed, the design may be viewed CLIENT for final approval. Minimal changes may be made at that time, but no changes may be made after final album approval. Changes in more than 10% of pages may incur additional charges. Production and delivery time will be approximately six weeks from final approval date.
