

**INSTRUCTIONS FOR CIRCULATORS
OF
TOWNSHIP SPECIAL ASSESSMENT PETITION
FOR THE U AVENUE AREA**

1. Only Owners of record title to the property in the special assessment district are eligible to sign the petition.
2. The deed holder(s) and the purchaser(s) under a land contract must both sign the petition.
3. All parties to joint deeds or land contracts must sign the petition.
4. Mortgage holders (mortgages) are not required to sign.
5. All record owners of property must sign the petition exactly as their names appear on the deed or land contract to their property.
6. Both husband and wife must sign. The wife must sign as Mary Doe and not as Mrs. John Doe.
7. More than one person may circulate the petition and must sign a circulating sheet in the back of the petition. This signature must be notarized. Circulator must witness all signatures on petition.
8. Signing the petition is an indication of support for a proposed project. Not signing the petition indicates a lack of support for a proposed project.

KALAMAZOO COUNTY, MICHIGAN:

We, the undersigned, support the implementation of a sanitary sewer collection and treatment system improvements project to serve our property.

We, the undersigned, generally understand and agree with the following:

- The initial projected user fee is estimated to be \$45 per month or less per home. The user fee will fund system operation and maintenance costs and replacement reserve funding for future system repairs.
- The initial projected benefit fee assessment per residential equivalent unit (REU) is estimated to be \$10,500 or less, and the initial projected parcel fee assessment is estimated to be \$1,000 per parcel or less, with the total special assessment for a single-family home totaling \$11,500 or less. These special assessments will fund system construction costs.
- The preliminary project layout and proposed special assessment district for the U Avenue area is depicted on the Wightman & Associates, Inc. drawing(s) on file at the Township offices.
- Sewer treatment services will be provided either by the City of Kalamazoo or a newly constructed sewage treatment facility owned by the South County Sewer and Water Authority.
- The currently projected user rates and special assessments, the preliminary project layout, and the proposed special assessment district are all subject to revision and approval by the Township.

We, the undersigned, being the record owners of more than 50% of the total land area in the special assessment district hereinafter described, do respectfully petition the Township Board of the Township of Schoolcraft, pursuant to Act 188, Public Acts of Michigan, 1954, as amended, to construct a sanitary sewer system in the Township of Schoolcraft to serve the U Avenue area and to create and establish a special assessment district for the purpose of assessing the cost of said improvements to benefited properties:
