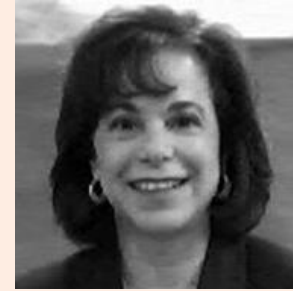

# LEA Plan Requirement for Funding

Local Educational Agencies (LEAs) operating Title III Limited English Proficient (LEP) and/or Immigrant programs must update, implement, and monitor Goal 2 of the LEA Plan for each fiscal year an application for subgrant funding is made. (20 U.S.C. §§ 6312 [b][1](A)(i), (ii), (iii), 6826).

For each program (LEP and/or Immigrant), for which the LEA is applying for in that grant year, the plan must include:

- Descriptions of the English learner program services to be provided
- Proposed budget for each program

# LEA Plan Requirement for Funding

- LEAs have until March 30, 2016, to submit substantially approvable plans.
- LEAs without substantially approvable plans by March 30, 2016, will not be considered for 2015–16 Title III funding.
- Funds will be released upon completion of all requirements in the next apportionment.

- The initial deadline for LEP (direct and Consortia) and/or Immigrant funding for 2015–16 has passed.
- CDE will continue considering late applicants until March 30, 2016

# 2014–15 Subgrantee Awards

- The 2014–15 funding application is closed.
- Final per pupil amounts for LEP and/or Immigrant funding are as follows:
  - LEP: \$98.37
  - Immigrant: \$92.95
  - Supplemental Immigrant : \$27.73

# 2013–14 Subgrantee Awards

- 2013–14 Title III, Part A per pupil amounts:
  - LEP: \$102.22
  - Immigrant: \$93.32
- LEP and/or Immigrant grant allocations are now final
  - Grant period ends September 30, 2015
  - LEAs have until December 30, 2015, to liquidate 2013–14 funding
  - End of Year Expenditure Reports must be filed in the Consolidated Application Reporting System (CARS) before February 28, 2016
