Enochs High School Student Parking Permit Application

Parking Rules and Regulations

- 1. All vehicles must be registered with the Supervision Office, and the Enochs High School parking permit <u>must be visibly displayed</u> in the front window on the mirror.
- 2. The student must possess a valid California Driver's license.
- 3. The student and his parents or guardians must assume liability for damage to school property.
- 4. The school cannot be responsible for damage or loss to any vehicle brought to school.
- 5. Vehicles are to be parked and not used during the school day except when prior approval has been granted by the school.
- 6. The student must park in the prescribed parking area in the spaces designated for students. This includes motorized two-wheeled vehicles.
- 7. Tickets will be issued to those in violation of regulations by campus supervision. This includes failure to properly display a permit for any reason at any time. If permit is lost or left in a different vehicle, student must obtain temporary permit from the supervision office as soon as they arrive to campus. Failure to use a temporary permit will result in a parking citation that will not be voided.
- 8. Speeding and reckless driving will be penalized through campus supervision and parents will be contacted.
- 9. Repeat offenders may be towed at the owner's expense and/or incur a loss of school driving privileges.
