# FEATURED ARTIST JERRY BELLAND

Jerrold (Jerry) Belland has an unusual artist's statement. He freely admits to liking Mad magazine more than Andy Warhol. He talks about his unconscious mind being in charge of any good artwork that he happens to make. He talks about his childhood exposure to the comics section of the Chicago Tribune as the most formative of his art experiences.

He has a graduate degree in Art from U.W.M. "I was never comfortable in grad school," he says. "I always felt that everyone else knew something I didn't."


He taught public school for 34 years at Racine's inner city Horlick High School. "Most of my friends on Facebook are former students. They remember my classes vividly. It was the most important work I've done."

Belland has exhibited widely in the state, and his work is in many Wisconsin public collections. "For a while there, the Percent for Art program was very good to me," he recalls.

In 2011 he won one of four Racine Art Museum Fellowships. His solo show is currently on display at Wustum Museum in Racine. "The Fellowship year pulled a lot of strings together for me," he says. "I finally have a vague idea of what I'm doing."

Part of what he's doing is rediscovering cartooning, an art form he excelled at while in high school. He talks of the "Old Jerry" channeling the "Young Jerry": and considers this thought process a collaboration.

"I want to think that these cartoons have their own spin," he says. "I want them to be cartoons that Carl Jung could have made. The deeper and darker they get, the more people see them as funny. 



# DIGITAL BILLBOARD ART IN MILWAUKEE

In October 2013, WVA member Claudette Lee-Roseland had thousands of people see one of her paintings on a Milwaukee digital billboard along highway 41. She was one of 25 artists who had art selected for Digital Billboard Art Month (DBAM)

IN:SITE, fostering temporary public art, organized DBAM. IN:SITE sent Clear Channel Outdoor and Lamar Advertising a letter in 2012 asking them to donate digital billboard space. Twenty people connected with visual arts groups, including WVA's Christine Buth-Furness, Gary John Gresl, and Christine Style, signed the letter. Both companies agreed, with Clear Channel donating twelve billboards and Lamar six. Digital billboards show multiple images, and both companies committed to at least one image per billboard October 1-10, 2013

After receiving input from a national advisory team to establish DBAM guidelines, IN:SITE approached 27 nonprofit City of Milwaukee visual arts

groups to request participation. Eighteen agreed, including WVA.

All of the of the groups submitted up to five images in May of 2013. There ensued a long process making sure the submissions were technically correct, that there weren't any guideline infractions, the billboard companies reviewed them (and did not reject any), and last Graeme Reid, Director of Collections and Exhibitions at the Museum of Wisconsin Art, reviewed them.

WVA submitted three images, and Reid selected Lee-Roseland's as the top choice. All the billboard images had a text panel with the name of the artist, the group, and the phrase Digital Billboard Art Month. IN:SITE chair Pegi Christiansen says, "The WVA panel was very strong. It glowed!"

# FEATURED ARTIST PATRICIA KELLER

Patricia Keller earned her B.S. in Art Education and M.F.A. in painting from the U.W. Madison. Since that time she has taught, exhibited her work regionally and nationally, and curated exhibits at the U.W. Madison's Steinhauer Trust Gallery.

Her work is centered around wilderness landscape, including the often overlooked close-in view of a micro-environment, such as the interior of a flower or the visual space between natural objects.

With an understanding that each of us brings our unique life experiences to each artwork we view, Keller's goal is to draw the viewer's attention into the painting--first by grabbing attention with the whole, then later beguiling with the parts. For that reason, much attention is paid to the negative spaces between objects. She enjoys the challenge of utilizing unlikely color, gestural line, and texture to accomplish these goals. *Prestige! Recognition! The Elite! The Anointed! The Chosen!* Exhibiting at the "best place" in order to gain the most exposure to the right people, the critics, the elite, the exclusive...the prominent and influential, and the potential money spenders.

In Wisconsin such places would likely include the most high profile venues which have the potential to gain most exposure, the largest public and the prominent media. These venues would include the Milwaukee Art Museum, The Madison Museum of Contemporary Art, The Museum of Wisconsin Art, The Haggerty, The Racine Art Museum, The Kohler Art Museum, and on to other cities with fine art museums... Manitowoc, Green Bay, Appleton, Beloit, Kenosha, Wausau; and I apologize for overlooking others which are important to their regional artists and audience.

But...each of us has a "product" that can be directed to persons and places other than those mentioned. Sometimes such places can reveal kinship in their missions, influences and subtle importance.

Why has graffiti/street art become so notable and influential? Why does tattoo art repeatedly surface as subject for exhibits? Why do birds dominate annually in Wausau...a show that travels extensively? Why do themed exhibits repeatedly manifest depending on the place, its history and local interests? Let us not ignore sometimes underrated art including flower arrangement, stage design, calligraphy, naïve, folk and primitive art including objects from wide ranging countries and cultures. (Consider the effects/influences that once denigrated or unfamiliar exotic works of art from both within and outside our regional and national areas have had on us and art history)

I have recently had an exhibit in the Urban Ecology Center at Riverside Park, Milwaukee, not among the most highly recognized or greatly respected venues. I sought a show there because of the interests of the people who attend and support that venue and its mission. My work relates to Nature, objects, personal evolution and the effects of the human presence on Earth. Despite the fact that the UEC has a gallery which shares duty as a community meeting room, a classroom and multi tasks for other activities, this site was nearly perfect for me. (Maybe one can consider it a "stealth gallery".) This is but one example of a less than "important and anointed" venue we might discover and consider.

Would we all like a presence in the Milwaukee Art Museum, etc.? Of course! But...there are many reasons for us to revel in our exhibits in the most remote of places, as long as those exhibits help fulfill our personal goals and perceptions. If we can reach like-minded persons, in fact minds that can be influenced, entertained and where we can share intellectual and aesthetic fellowship, then we have fulfilled important goals...reason enough to create and expend our efforts.

Perhaps we can think of those butterflies flapping their lovely wings in the most remote of places...eventually stirring up hurricanes in the lives of viewers we will never meet.

### ARTIST BEWARE - by Bonnie de Arteaga

I'm embarrassed to say, I fell for it. He was charming, and oh so handsome. He was from New York and had exquisite taste in interior décor. And he told me I was his favorite artist.

At first he brought clients to my booth at art shows. They bought my work. I got paid. He placed my work in his design showroom. He placed my work in local business. They bought my work. I got full price.

I asked him how he would make money on my work if he gave me full price? He said he would add his finder's fee onto the work and give me my price.

But... I always had to have the paperwork. I had to find him to sign my loan agreements. He sent me personal checks with no paperwork or receipts. I started to get confused about what was sold and what was not. Sometimes his showroom manager would sign the loan agreement when I dropped off work. When I could get hold of him, he told me I was his favorite artist.

His business was not doing well. He let his manager go. He decided to shut down his showroom and move his business into his home. I came to pick up my work with what inventory documentation I was able to keep track of. He said I really should be showing my work in New York.

There was a piece unaccounted for. I had left it with a signed receipt with the showroom manager. I asked if it were sold

or on display? He said he never saw the piece and had no knowledge of what I was talking about. I called the ex-manager. She said she didn't know anything about what happened to the piece.

There was another missing piece on approval at someone's home. It had been there awhile. I told him I either wanted the money or I wanted the piece returned. He said it was in their summer home and they were about to close for the winter. WHAT?

I wanted it back immediately. He stopped taking my calls. His wife would say he was sleeping. His wife would say he was in New York. I sued. A TV courtroom show contacted both of us about televising our case. I could just picture it – Svengali dealer vs starving artist. I considered it for about 30 seconds.

Suddenly my art appeared from the summer home and I got it back. I dropped the suit because I didn't have a good enough paper trail to prove exactly what was paid for and what was not. There was still one piece of my work missing.

Moral of the story: maintain scrupulous paperwork. Photocopy all checks and link them to your specific work. Insist on signed documents for every exchange of money, exhibition details and art. And oh yeah, don't fall for the sweet talk!

For her water media pieces, she begins each piece with thoroughly soaked, heavy watercolor paper and large brushes loaded with paint. Paint flowing over the surface will suggest details which can later be developed. The composition is refined as the work dries. Later, the finer details are enhanced with combinations of water based media. This process allows for imagination to come into play--not unlike the way we find shapes in clouds passing by.
