1. Welcome and Announcements

ARC Staff

Dan Reuter of ARC welcomed the group and reviewed the announcements from the agenda, which is available on the LUCC webpage.

2. PATH 400 / Livable Buckhead Update

Denise Starling, Livable Buckhead / BATMA

Denise Starling of Livable Buckhead presented on several community development, recreation, beautification, greenspace, and planning projects currently being undertaken in Buckhead. These include PATH 400, the Buckhead Village and Buckhead Core SPI zoning updates, a pedestrian circulation plan, and conceptual discussions around the potential for capping GA 400. 3. The State of Housing in Metro Atlanta

Mike Carnathan, ARC

Mike Carnathan of ARC outlined current housing issues in metro Atlanta. Home sales and building permits are on the rise, along with average home price. However, the geographic distribution of the housing recovery is very uneven across the region. Many areas of metro Atlanta still exhibit low home prices, little to no building activity, and disproportionately high shares of homes with underwater mortgages. Many parts of the region also struggle with housing affordability, often due to combined housing and transportation costs for the average household. In addition, the Atlanta region ranks in the top one percent in the nation in terms of the number of zip codes with high levels of negative equity. 4. Discussion of The Region's Plan – Draft Objectives and Policies

ARC Staff

Dan Reuter discussed The Region's Plan and provided an overview of the current draft Objectives and Policies that frame the plan. He asked for input from the committee and led a discussion on the subject. Key points included:

- The objectives and policies under "World Class Infrastructure" should:
 - Include the need to identify new and better funding mechanisms to address the regional infrastructure backlog
 - Clearly define Regional Places (see Goal 1, Objective 2)
 - Include the need for transportation infrastructure to incorporate accessibility and universal design
- The objectives and policies under "Healthy, Livable Communities" should:
 - Include the need to connect decisions to health impacts (see Goal 2, Objective 1 social determinants of health, etc.)
 - Call out the need for brownfield redevelopment (potentially under Goal 1, Objective 2)
 - Contain stronger references to green infrastructure, conservation and greenspace for public health, environmental benefits, and climate change resiliency (see Goal 2, Objectives 1-2)
 - Include the need for the built environment to incorporate accessibility and universal design
