Hello:

The 2015 Nevada State 4-H Shooting Sports Match, hosted by Douglas County 4-H Shooting Sports and Douglas County 4-H, takes place Saturday, September $12t^{h}$ at the Douglas County Fairgrounds and Shooting Range. Both are located at the south end of Gardnerville 2 miles off Hwy 395 – see directions attached. This year Early Check-In takes place 6-8 p.m. Friday night at Douglas County Fairgrounds. Check-In continues Saturday morning 6-7 am at Douglas County Fairgrounds followed by 7:00 am Opening Ceremony (Pledges, Introductions, Instructions) at the Range. Douglas County Fairgrounds serves as contest headquarters for Contest Check-in and tabulation of scoring from the 6 ranges. Archery, Air pistol, Air Rifle, .22 Rifle, Shotgun and Muzzleloader competitions take place at the Douglas County Range north of the fairgrounds. **Contestants must provide their own ammunition.**

Breakfast and lunch are available to purchase Saturday at the range. Following all shoots, a barbeque/picnic for contestants and their families will be held at Douglas County Fairgrounds. Cost \$5 per participant and youth under age 10, \$15 per non-participant and people age 11 and older. The Awards Ceremony takes place at 7:00 pm following the barbeque/picnic (dependent on completion of scoring and tabulation).

Enclosed are directions, hotel/motel and camper information, contest schedule, helpful hints, barbeque/picnic form, assumption of risk form, photo release form, and entry form which should provide you with enough details and information to enhance your awareness and participation in this event. *Please read all packet information so that errors and misunderstandings are held to a minimum or eliminated*.

The Contest Entry Form & Fees (checks made out to Board of Regents), Assumption of Risk Form, and Photo Release Form are due to the Nevada State 4-H Office no later than Friday, August 21st. *The Barbeque/Picnic Form & Fees are due to Carson Valley Shepherds no later than Friday, August 14th. Checks made out to: Carson Valley Shepherds*

2015 Nevada State 4-H Shooting Sports Match Helpful Hints & Guidelines

- Safety is our first concern. All safety procedures must be and will be practiced at all times and all safety procedures will be enforced at all times.
- The purpose of the State 4-H Shooting Sports Match (like all 4-H Activities) is for participants to have a safe environment, make new friends, derive something (information, skill, etc) that will facilitate and/or enhance their personal growth and development, and demonstrate skills and knowledge garnered from participation in 4-H Educational Activities (club meetings, clinics, workshops, etc).
- All contestants must furnish their own ammunition and CBI's.
- Contestants and guests are advised to bring chairs, sun shades, hats, sunscreen, and water. There is limited seating available at the range. Please leave your dogs at home. No dogs allowed at the Fairgrounds or at the Range.
 - Contestants with special needs at the range must make those needs known prior to the event. A physicians' letter stating any physical challenges and request for special consideration while competing must accompany the registration form.
 - All contestants must wear 4-H Dress to the Awards Ceremony. 4-H Dress is not required while participating in the actual competition. Dress for competition is long-sleeved shirt (meaning from shoulders to wrists) or club T-shirt, long pants (meaning from waist to ankles), and shoes that are closed-toed/closed-heeled and that are at least ankle high.
- The Nevada State 4-H Shooting Sports Match Early Check-In is 6 8 p.m. at Douglas County Fairgrounds. For those who do not want to check in Friday night, Saturday morning Check In begins at 6:00am. Remember, you are responsible for signing up for your time slot to shoot. Contact information/cell phone numbers must be provided at the Check-In.
- All contestants need to be at the contest at the start of the day Saturday, September 12.
- Contestants need to be punctual to their designated rotation. Late shooters may not be allowed to shoot.
- Contestants will not be allowed to shoot in a different rotation or shoot early/late in their disciplines.
- Shooters must be available in the event of a tie-breaker shoot-off. If a tie cannot be broken by a shoot-off, the Nevada 4-H Shooting Sports Advisory Committee will make the final decision.
