Brazil visa processing times for residents of Alaska, Northern and Central California, Florida, New Jersey, New York, Oregon, Pennsylvania, and Washington state are taking 9-12 weeks depending on the volume of requests received by the consulate. Dear Traveler,

As you prepare for your upcoming program with Gohagan & Company, we would like to remind you that a visa is required for your *Iguazú Falls* Post-Program Option for the excursion to Brazil. This visa must be obtained in advance of your departure from the US.

Gohagan & Company has arranged with G3 Global Services to offer the most convenient way to obtain your visa(s). The following information is specifically tailored to travelers who choose to apply through G3.

We recommend that you apply for your visa at least 90 days prior to your US departure. Brazil visa processing times may be extended for residents of Alaska, Northern and Central California, Florida, New Jersey, New York, Oregon, Pennsylvania, and Washingtonstate. Please use a delivery service with a tracking number, such as FedEx or USPS Express Mail, when sending in your passport and application to the visa service.

Please ensure that your passport has at least two blank "Visas" pages facing each other and will be valid for at least six months following your tour. G3 can assist with passport renewals and additional pages, if necessary.

G3 can also assist with the payment of your Reciprocity Fee for Argentina.

- Your original valid signed passport. It must have at least two blank pages marked "Visas" side by side and more than six months before expiry.
- □ One Brazil visa application form, completed online, printed, and signed. Select the "Visa Request" link at https://scedv.serpro.gov.br. You may need to confirm a security exception in order to begin. All questions on the online application must be answered. Make sure your name is typed in exactly as listed in your passport and that your signature does not extend beyond the signature box on the printed application.
