

IMPORTANT VISA INFORMATION

Dear Traveler,

As you prepare for your upcoming trip to Brazil, we would like to inform you that a tourist visa is required for your visit to Brazil. This visa must be obtained in advance of your departure from the United States.

We have enclosed complete visa instructions, including a visa application and an instruction sheet from G3 Global Services, LLC, the visa service we recommend. Please note that there are additional requirements listed for travelers under age 18.

We recommend that you apply for your visa at least 12 weeks prior to your US departure. Visa processing times for Brazil are quite lengthy and can be in excess of 30 business days. Please use a delivery service with a tracking number, such as FedEx or USPS Express Mail, when sending in your passport and application to the visa service.

Please ensure that your passport has at least two sets of blank pages marked "Visas" and will be valid for at least six months following your tour. G3 can assist with passport renewals and additional pages, if necessary.

Send the following documents to G3:

Your valid, signed US passport. Your passport must have two blank pages labeled "Visas" and be valid for more than six months beyond the end of your trip.

One 2" x 2" passport size photograph with white background.

One visa application form, completed online at <u>https://scedv.serpro.gov.br</u> and printed. Select the "Visa Request" link to begin. You may need to confirm a security exception in order to access the application. <u>All questions on the online application must be answered.</u> Make sure your name is typed in exactly as listed in your passport. The printed application must be signed with a pen-to-paper signature; make sure the signature matches the signature in the passport and does not extend beyond the box. A sample application is attached.

- Original or certified copy of your birth certificate showing both parents' names, plus one photocopy.
- Copy of a recent bank statement. Account numbers may be blacked out for privacy; do not cover other information.
- A Certificate of Good Conduct or police report demonstrating no criminal record.
- A copy of your international flight itinerary showing your entry to and exit from Brazil.
- A copy of your state-issued driver's license.
 - Non-U.S. citizens, submit a valid I-94 or copy of Permanent Resident Card.

Send all documents to G3's Miami office using an express delivery service such as Federal Express.
