#### Final notice on delinquent members coming soon

With less than two months left in the lodge year, we still have 22 members who have not paid their current dues.

Section 14.160 of the Statues Annotated, state the Lodge Secretary "shall provide notice in Section 1.115 informing the Member that such Member may be dropped if dues are not paid within 30 days of the mailing notice. At the time the Lodge Secretary gives notice to the Member, the Lodge Secretary shall post a list of all members given notice on the Lodge Bulletin Board and report the posting the list at the next Lodge meeting." Some delinquent members have been Elks for 25 years or more while a few were just initiated last year. There may be a valid reason why you choose not to remain a member and that's why we'd like you to share this information with us.

If your lodge has not lived up to your expectations, please tell us why. We can't fix a problem unless we know it exists.

We also know that some of you may have financial or health problems. In that case, we can make arrangements to keep you on the active membership roster. Any information you share with us will be kept strictly confidential.

But we can't do anything unless you communicate with us.

Every member is important to us, whether they visit us once a year or once a day. We were proud to have you as a member when you first joined the Sebasticook Valley Lodge. Now tell us what we can do to keep you.

#### Quiz show, comic book unveiled to boost drug awareness

The Elks Drug Awareness Program is announcing a new opportunity for Lodges beginning in 2015-2016, the Elks Drug Quiz Show.

Introduced at the Elks Drug Awareness Workshop at the 2014 Convention in New Orleans, the quiz show strives to assist youth in grades 5-8 in making healthy decisions.

Youngsters sign up in a team of up to seven and study materials provided to them. All questions are based upon the supplied materials.

First-round questions are answered by the team, the second round individually and third round by using the game buzzer and light system. Winners proceed to state competitions. Competing Lodges are assisted by representatives of the Elks Drug Awareness Program. For information for your Lodge or schools, contact Hope Woodcock-Ross at

The Elks Drug Quiz Show, fully funded by the Elks National Foundation, is endorsed by more than 25 organizations including the American Cancer Society, SAMHSA, the DEA, the CDC and the U.S. Department of Health.'

Also introduced at the New Orleans Convention was the Drug Awareness Program's comic book, "Never Alone," featuring Marvel Super Heroes, The Avengers, as they join Elroy the Elk in fighting evil to prove that every kid can be in charge of his or her own destiny! This comic book is not available for mass distribution from the Elks, but is available to certain schools engaged in direct mailing from Marvel Comics...But!!

Next month's article will detail how your Lodge might be able to secure a spot on Marvel's data base. Remember: There will be no guarantee that your school will be selected by Marvel, but if you are already doing Hoop Shoot etc. in your local schools, the chances are better if you follow the details...next month!
