- Only one school at a time can access a student's record.
- Though you may have applied to several schools, you will need to specify ONE school to which you plan to transfer.
- We will use end date of current semester/term at Virginia Tech as your transfer release date. Your new school will not be able to issue you a SEVIS I-20 or DS-2019 or access your record until the transfer release date. You may request an earlier release date PROVIDED you (1) state the reason for the request and (2) attach supporting documents (Acceptance letter including reporting date, advising date and/or testing date).
- If you decide to continue at Virginia Tech and not transfer out, you MUST notify IGSS <u>BEFORE</u> the transfer release date. IGSS will not have access to your record once the transfer date is reached.
- This procedure is only for release of your SEVIS record to the transfer school. You must still complete the transfer procedure by reporting to and registering at your new school.
