Crucial Conversations to Support Family Engagement

These conversations are especially charged when the discussion occurs between people from different cultures, genders, & status groups. This workshop will explore methods for facing these crucial conversations & provide tools that will help you handle them effectively. The practical, hands-on tools offered are designed to: master the crucial conversations; promote a safe environment in which others are encouraged to speak freely; offer techniques for speaking persuasively & not abrasively; introduce ways to suspend judgment; & translate crucial conversations into action plans that get results.
