The Automotive Maintenance and Light Repair 1 course prepares students for entry into Automotive Maintenance and Light Repair 2. Students explore career opportunities and requirements of a professional service technician. Content emphasizes beginning transportation service skills and workplace success skills. Students study safety, tools, equipment, shop operations, basic engine fundamentals, and basic technician skills.

The objective for this course is that student would become proficient in automotive safety. Students will also learn how to use tools correctly and determine what tools are needed for a job.

D. End of Course/Required Assessment

This course prepares students to take the ASE G1 and FADA in there 11th and 12th grade years. For this course there is a locally created assesment or LCA that is administered in two parts first half is at semester exam time and the other half is at final exam time. Just as a note students are not automaticly advance to the next year automotive class. Their performance and attitude will be taken into account for advancement in the automotive program.

F. Types of Assignments:

We are using the CDX automotive software so are students have endless oppertunitys to cover the martieral the students will be given a log in and password within the first two weeks of school to gain access to CDX online. There the students will be completing most of their classwork/homework though online modules. Along with the online portion students will have other in class assingments and there will be test that are also a part of the CDX online. The final type of assingment will be in shop proficiency that students will be required to complet tasks in the automotive lab.

Class work and Home work	= 33% of total grade
