- All tickets must be purchased by MVHS students @ lunch in the student store beginning Thursday, March 10th through Thursday, March 17th unless otherwise specified. Student must present ID card at time of purchase.

ADMITTANCE

- Spring Dance is for MVHS students ONLY. No outside guests will be permitted.
- · Admittance/attendance is subject to MVHS Administration approval.
- Attendance at MVHS dances is a <u>privilege</u>, not a right, which may be revoked for lack of responsibility at school including, but not limited to: unpaid fines, unfulfilled Saturday schools, serious (suspension/expulsion) or chronic discipline issues, unsatisfactory attendance, or failing grades. Any student that has received a "Not in Good Standing List letter" will not be allowed to attend.
- ALL ATTENDEES MUST PRESENT THEIR CURRENT SCHOOL ID CARD AT THE REGISTRATION TABLE AT THE DANCE TO BE ADMITTED. NO STUDENT ID CARD, NO ENTRANCE!
- NO STUDENT/ATTENDEE WILL BE ADMITTED AFTER 8:15 P.M. unless prior written arrangements have been approved with the Activities Director, Mr. Perez. Students are required to stay until 9:30 P.M. before they will be released.
- Students or guests who leave during the dance will not be readmitted.
- Student(s) must be picked up by no later than 10:15 pm.

RULES

- 1. All school rules and regulations are in force during any school event.
- 2. All students may be searched for weapons, illegal substances, etc. prior to entry of the dance area
- 3. <u>All attendees may be subject to a random alcohol screening test given by Mission Viejo High School Administration.</u>

In addition, any student showing observable signs of using alcohol or any controlled or illegal substance will be subject to an alcohol screening test and removed from the dance by Administration. The OC Sheriff's Dept. & parents will be notified. (*Education Code 48900(c) & 48900(s) prohibits the use/possession of alcohol, intoxicants and controlled substances at school, on the way to/from school or at any school related activity)*

4. Forgery of any part of this behavior contract will lead to non-attendance at the dance and disciplinary actions as determined by the Administration.

CONDUCT

- 1. No inappropriate dancing (deemed by MVHS Administration) such as freaking, moshing, slamming, back to front dancing, bending over, leg or hip riding, etc. will be permitted.
- 2. NOTE: Violation of the dancing policy will consist of removal from the dance and forfeiture of attendance to Prom.

DRESS CODE

Casual attired is permitted for the Spring Dance. School dress code will be enforced and must be adhered to. NO COSTUMES or full face paint nor any other clothing deemed inappropriate by the Mission Viejo High School Administration. If dress code violations occur after admittance, student/attendee may be removed from the dance.
