Billboard Sign	a ground sign that advertises goods, products, or services not sold or offered on the property where the sign is located, and the sign is either single faced or double faced	\$161.00 per sign
Ground Sign	a sign supported by uprights or braces embedded in a foundation or embedded directly in the ground	\$79.00 per sign
Fascia Sign	a sign attached to, marked or inscribed on, erected or placed against a wall forming part of a building, or supported by or through a wall of a building, including a painted wall sign and an awning sign. A fascia sign shall not include any other sign defined in this By-law unless otherwise stated	\$79.00 per sign
