## Re: Information Request – Freedom of Information Act (FOIA) 2000


I can confirm that the Health and Social Care Information Centre (HSCIC) has considered your query received by us on the 2nd September 2015.



Please note that we have redacted the names of some individuals cited in these documents as they are exempt information under Section 40 (Personal Information) of FOIA. This is in line with guidance



issued by the Information Commissioner's Office in relation to the release of personal information in respect of staff not at a senior level.

Section 40 – 'Personal Information' is an absolute exemption and is therefore not subject to a public interest test.

"C" denotes a cancer registration is held relating to the individual. Information is also held relating to the place and date of death of the individual. This information is exempt from disclosure under Section 44 (Prohibitions on Disclosure) of the Freedom of Information Act 2000. The HSCIC is prohibited from releasing this information under Section 39 1 (C) of the Statistics and Registration Service Act 2007.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the HSCIC website.
