PARTICIPANT AGREEMENT, INDEMNIFICATION, RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK

PLEASE READ THIS DOCUMENT CAREFULLY.

BY SIGNING THIS DOCUMENT YOU ARE GIVING UP YOUR AND YOUR MINOR CHILD'S LEGAL RIGHTS.

I understand that trampolining and/or participating in any activities in, on, around, in connection with or associated with trampolines or any other activities (hereinafter, the "Activities") on the premises operated by Epic Air, LLC and/or Epic Air Trampoline Park and/or any of their owners, officers, directors, managers, employees, representatives, agents, parents, subsidiaries, and other affiliates (collectively, "Epic Air") are inherently dangerous Activities, involving known and unknown risks of physical and/or mental injury, including but not limited to permanent physical and/or mental injury and even death.

In consideration of Epic Air permitting me and/or the child for whom I am a parent or legal guardian (my "Child") to participate in any such Activities on the premises operated by Epic Air, I, on behalf of myself, and on behalf of my Child, and further including my heirs, agents, assigns, family members, spouse, domestic partner, parents, children, estate, and any other persons acting or purporting to act on my or my Child's behalf, do hereby expressly and voluntarily release, remise, discharge, defend and agree to fully indemnify Epic Air and its direct and indirect owners, officers, directors, managers, employees, representatives, agents, parents, subsidiaries, and other affiliates from any and all liability that may arise, as more specifically described as follows:

RELEASE OF LIABILITY: I hereby release, remise, acquit, discharge, covenant not to sue, agree to defend, indemnify, and hold harmless Epic Air, from any and all liability, claims, demands, actions or causes of action, damages, suits, debts, sums of money, accounts, reckonings, bonds, bills, trespasses, damages, judgments, executions, claims and demands whatsoever in law or in equity, for, upon or by reason of any matter, cause or thing whatsoever, including but not limited to any physical or mental injuries or death suffered by me or my Child, incidental to, arising out of, or connected with my or my Child's participation in the Activities, including such injuries or death caused by or as a result of Epic Air's negligence.

The hearing shall be conducted in either the City of Chicago or Kane County, Illinois, unless both parties consent to a different location. **THE DECISION OF THE ARBITRATOR SHALL BE FINAL AND BINDING UPON ALL PARTIES.** The prevailing party to any such arbitration shall be entitled to an award of its reasonable attorneys' fees and costs incurred as a result of its participation in the arbitration.

INDEMNIFICATION: I specifically and additionally, on behalf of myself and my minor Child, agree to indemnify and hold harmless Epic Air from and against any and all losses, liabilities, claims, obligations, costs, damages and/or expenses whatsoever paid, incurred, and/or suffered by Epic Air, including but not limited to, reasonable attorneys' fees, costs, damages, and/or judgments incurred as a result of my or my Child causing any injury, damage, or harm to Epic Air or any and all other person.

THE MONARCH AWARD: ILLINOIS' K-3 READERS' CHOICE AWARD

The Monarch Award: Illinois' K-3 Readers' Choice Award is presented annually to the author and illustrator of the book voted as their favorite by students in Kindergarten through grade three in participating Illinois schools or public libraries. The Monarch Award is sponsored by the Illinois School Library Media Association.

The Monarch Award is designed to encourage Illinois children to read critically and to become familiar with children's books, authors and illustrators. The award is named for the Monarch Butterfly and symbolizes the growth, change and freedom that characterize the emergent reader. Children who have read or had read to them at least **5 of the 20** Master List titles are eligible to vote.

THE BLUESTEM AWARD: ILLINOIS' 3-5 READERS' CHOICE AWARD

The Bluestem Award is designed for students in grades 3-5 who are ready for longer titles than found on the Monarch list, but not quite ready for the sophistication of some of the Rebecca Caudill titles. Named in honor of Big Bluestem which is the state prairie grass, the award may include both timeless classics and current titles, as well as books that have appeared on Monarch and Rebecca Caudill lists. Any Illinois student in grades 3-5 during the school year of the award may participate. Participants must read, or have read to them, **4 of the 20** nominated books.

Participation in the state book award programs is optional. Books are available for checkout at both the school and public library. Books need to be read by March 6th. Voting will take place the week of March 9th.
