## Voluntary Plea Transcript

*I understand that:*

I am pleading Guilty to the following charges which will stay on my record forever:

UNSUPERVISED probation means that I must (A) commit no offense other crimes, (B) possess no weapons, (C) remain employed or in school or take vocational training to help get job (D) pay any child support. Any money that I owe will have to be paid today or by a compliance date set by the Judge.

SUPERVISED probation means that I must (A) commit no offense other crimes, (B) possess no weapons, (C) remain employed or in school or take vocational training to help get job (D) pay any child support, (E) remain in Durham County unless there is written permission from PO, (F) Report to PO for office visits (G) tell PO about changes in address and employment status, (H) pay a supervision fee of about \$\_\_\_ per month. Any money that I owe will be paid over the course of probation, and I need to pay something each month.

Intensive probation means that I do everything under supervised probation, and (A) 50 hours of community service and \$\_\_\_ CS fee, (B) Submit to curfew, (C) periodic drug testing, and participate in education or vocational training arranged by PO.

I must serve a part of my sentence in jail. I will spend \_\_\_\_\_ days in jail before I am released to begin my probation

If I fail to follow what is required on probation then the court will revoke my probation and require that I serve the active time in jail.

I have been offered a deferred prosecution through the first offenders program. This means that I will have to perform \_\_\_\_ hours of community service within \_\_\_\_ months, and pay the cost of court (\$100) and community service fee (\$\_\_\_\_). For \_\_\_\_ months I cannot commit any criminal offenses.

I have been offered a deferred prosecution agreement with the State. This means that I admit guilt, and once I complete all of the other conditions of my plea agreement, the State will dismiss my case and it will not appear as a conviction on my criminal record. I am placed on SUPERVISED/UNSUPERVISED probation for \_\_\_\_\_ Months

If I have three felony convictions - back to back - , then my fourth felony conviction may be indicted as a habitual felon (class C)
