\$60,000 Donated for Pulmonary Research

The Richard H. Moy, M.D. Pulmonary Research Fund has received \$60,000 from the American Lung Association of Illinois. The Fund, now in its seventh year, promotes research in pulmonary medicine and supports the Association's ongoing partnership with the SIU School of Medicine in the battle against lung disease.

"The partnership between SIU School of Medicine and the American Lung Association of Illinois has created a greater awareness of the necessity to work together in order to win the fight against lung disease," says Dawn Kuhn, director of the central service area for the American Lung Association.

The money was raised June 5 at the annual Springfield Golf Classic[™] at the Panther Creek Country Club. Mark Watson of CDS Office Technologies chaired the committee that planned the event. Co-chairs of the event were John Ross of Raymond James Financial Services, and Joe Ushman of Ushman Communications. Corporate Sponsors were Blue Cross/Blue Shield, HPR Automotive Group, and CDS Office Technologies. Supporting sponsors were The Printing Center, NewsChannel 20, and WMAY/WNNS.

The golf outing continues to grow every year, says Kuhn, who is the event director, with 216 people participating this year. With continued growth, she expects that the golf outing will expand to two golf courses.

That could mean more money for researchers like Kounosuke Watabe, Ph.D., who received funds from this year's grant. Dr. Watabe is working to develop new clinical strategies for treating patients with lung cancer by restoring the function of a gene that stops tumors from spreading. ■

In addition to providing a financial benefit to the School of Medicine, these types of giving vehicles can result in substantial tax savings and tax deductions.

If you are considering a gift of noncash assets, it is important to plan your gift as soon as possible due to the complexity of some transactions. In some types of gifts, such as trusts or annuities, careful planning by both the donor's financial representatives and School financial planners is required.
