AFFIDAVIT OF SUPPORT OVERVIEW

This Affidavit of Support is used as a detailed statement of financial resources. It must be **accompanied by a bank statement**. This indicates that you have sufficient funds to finance your education at Midlands Technical College. This form must indicate how much money, in U.S. dollars, will be available to you **per year** to meet the cost of your education. It must also provide the source of the money. You are required to deposit \$12,222 in an escrow account at Midlands Technical College to cover the **estimated** cost of your tuition (\$11,304) and **student fees** (\$918) for your **first two semesters**. This is based on 12 credit hours (full time) per semester.

There is a 2.5% service charge for credit card payments for tuition and fees. This service fee will appear on your credit card bill as a separate line item. This is a nonrefundable fee.
