Not all of these jobs may be available at all parks. Since the nature of the Park Service is to serve the public, these jobs will require evening, weekends and holidays. NOTE: All lifeguard applicants for the State Park Service jobs are required to be tested by the Division of Parks and Forestry before an interview is granted. The application deadline for all positions is May 1, 2016.
