This privacy policy sets out how CAPR-STYLE LTD. uses and protects any information that you give capr-style.com when you use this website.

CAPR-STYLE LTD. is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

CAPR-STYLE LTD. may change this policy from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. This policy is effective from December 2013.

We are committed to complying with the Data Protection Act 1998 and have published this guide to help you understand how and why CAPR-STYLE LTD. collect information from you, to whom such information is disclosed and what your rights are.

You can access our Website home page and browse our site without disclosing your personal data. However, when you register at capr-style.com you will be asked to provide certain information about yourself, just because we want to get to know you better.

What information we collect

We may collect the following information:

- name and title
- contact information address, telephone number and email address so that we can process and fulfil your order and notify you of your order status
- demographic information such as postcode, preferences and interests to inform you of special offers and promotions

What we do with the information we gather

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Process your orders

- Internal record keeping.
- We may use the information to improve our products and services.
- We may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided.
- From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone, fax or mail. We may use the information to customise the website according to your interests.

Controlling your personal information

Use of Credit Reference Agency Information and sharing of credit information.

In the interests of responsible lending and for security purposes we carry out searches with credit reference agencies when you register with capr-style.com and further searches may be carried out before deciding whether to accept orders and/or grant further credit. The agencies record these searches. We also share information about you and the conduct of your account with credit reference agencies, other lenders and relevant third parties.

We may also use your information for payment recovery or fraud and debt tracing. We will pass on details of defaulting accounts to debt collection agencies.

How to increase security

Internet shopping is becoming more and more popular and the overwhelming majority of transactions are quick, easy and trouble-free. We do everything we can to ensure your shopping experience is as safe and secure as possible.

However, there are a number of additional precautions you can take to increase security:

- We recommend you always close down your Internet browser when you have finished shopping online, especially if you use a shared PC. This on many browsers will delete temporary Internet cookies from any sites you may have visited. Cookies

We use small text files called "cookies" which are placed on your computer's hard drive, phone or other web enabled device to assist in providing a more customised website experience. The use of cookies is now standard operating procedure for most websites. However, if you are uncomfortable with the use of cookies most browsers now permit users to opt-out of receiving them.

They are not harmful and do not contain any confidential information such as your home address, date of birth or credit card details.

In addition we have implemented a feature when you first visit this site which links through to this Privacy Policy page. You can opt-out of having cookies stored on your computer is to not browse this web site or to turn off cookies in your browser settings. It is possible to use this site without cookies if you are not a logged in user, however some features may be missed or not work as expected. If you don't want to allow cookies check the cookies opt-out box.

Google Analytics tracking is disabled until you implicitly or explicitly agree to this site's Cookie Policy.

Once you agree (by not clicking the box of cookies use), the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Capr-Style website uses cookies to allow customers to move from one part of the web site to another and to add items to the shopping basket without having to login repeatedly.

Cookies are used on our site for the following reasons:
