SCHOLARSHIP INFORMATION

This Scholarship is made possible by the Ryder Roundtable. The Ryder Roundtable is an organization of select individuals who have obtained membership by demonstrating sales excellence.

The purpose of the scholarship is to assist children of Ryder employees in furthering their education and accomplishing their ambitions.

To Apply:

- **1.** *Fill out application in full. (Type or use black ink only).*
- **2.** Attach a legible transcript of last full year of school completed. (Mandatory for eligibility.) Be sure to include your school's grading system (e.g. 93-100=A, 89-92=B; etc). Also provide the formula used for calculating GPA (e.g. A=4, B=3, or A=5, B=4, etc).
- **3.** IMPORTANT: To get the fullest consideration, you MUST submit with your application, a brief autobiography giving extracurricular activities, work experience, special awards you've earned, ambitions, personal goals, etc. Omission of this item could eliminate an applicant in the later stages of judging.

5. You are welcome to re-apply if you entered last year. Any previous winner can re-apply except the \$10,000 scholarship winner.

Qualifications:

- **1.** You must be enrolled in or applied to an accredited institution of higher learning (includes college, technical/trade school, etc.).
- **2.** All candidates must be members of the immediate family of a full-time Ryder employee who has been employed by Ryder for at least one year or a retired Ryder employee or a deceased Ryder employee. The immediate family member must also be employed by Ryder at the time that the scholarship award is announced and at the time the scholarship committee awards the scholarship check unless the committee determines in its sole discretion that employment was involuntarily terminated due to circumstances beyond the employee's control (i.e. loss of business or a reduction in force). No part-time employee may apply.
- **3.**APPLICATIONS MUST BE POSTMARKED BY MIDNIGHT DECEMBER 31, 2009.

Selection:

- **1.** All applications received by the deadline date will receive an email acknowledgement.
- **2.** *Judging will be the responsibility of the Board of Directors of the Ryder Roundtable.*
- **3.** All applications and transcripts become the property of Ryder and will not be returned.
- **4.** One \$10,000 scholarship will be awarded plus one \$7,500 runner-up scholarship, two \$5,000 runner-up scholarships and one \$2,500 runner-up scholarship. Winners will be notified by mid-March.
- **5.** Selection of scholarship recipients will be based on scholastic achievement, extracurricular activities, and financial need.
