CONDITIONS FOR COLLECTING BELONGER CARDS

Please note that applicants who are 18 years of age and over are expected to appear in person to receive their TC Islander Card. If the applicant cannot appear in person and would like to have someone collect his/her]C Islander Card, this person must have a typed and signed letter of consent from the applicant allowing him/ her to collect the TC1slander Card as well as a valid picture ID for verification.

In the case of persons under the age of 18, either parent of the child is required to appear in person to receive the child's TC Islander Card. (bring along a valid picture ID!) Any other person, who is not the parent of the child, is required to produce a typed and signed letter of consent from the mother or father along with a valid picture ID, to collect the child's TC1slander Card. All consent letters must be typed on a plain sheet of 8.5" X 11" sized paper. It should include the date, applicant's name, the collector's name, and the applicant's signature. The TC Islander Card may not be released if the applicant fails to comply.

TC Islander Cards cannot be mailed nor can they be collected by anyone under the age of 1
