Special Resolution

That, with effect from 1st April 2016, the Articles of Association be amended to read as follows:-

Article 4b

Every person who wishes to become a member of the Company or who wishes to renew his membership of the Company shall deliver to the Company, duly executed by him, an application for membership or consent to become a member of the Company, in either case, in such form as the Executive Council requires. Upon receipt of any application for membership and subject to:-

- i. The approval of the Executive Council
- ii. The payment of the minimum subscription in respect of the category for the then current year and
- iii. The provisions of Article 4

The Secretary shall enter the name of such person in the Register of Members of the Company and upon such entry, such person shall become a member.

Article 5b

The annual subscription payable to the Company by each member shall be payable to the Company before the expiry of any previous period of membership.
