## MEDICAID MEMO

SUBJECT: Intellectual Disability On-line System – *Effective Immediately* 

The purpose of this memorandum is to confirm to the above-referenced providers that the Department of Medical Assistance Services (DMAS) permits providers to electronically file certain forms via the Intellectual Disability On-Line System (IDOLS), implemented by the Department of Behavioral Health and Developmental Services (DBHDS) on June 23, 2011. DMAS is currently in the process of updating the Community Mental Health Rehabilitative Services Manual and the Mental Retardation/Intellectual Disability Community Services Manual to reflect this change. In the interim the above-referenced providers may rely upon this Memorandum as authority to use the IDOLS, in lieu of the paper forms listed below.

In 2006, the Centers for Medicaid and Medicare Services (CMS), the federal Medicaid oversight agency, awarded Virginia a Systems Transformation Grant aimed at creating system and service efficiencies. Part of that grant was used to create IDOLS, a web-based system used to improve and streamline Intellectual Disability (ID) Waiver services for individuals and their families. The system will track the ID Waiver waiting list, enrollment, requests for services and service authorization(s). The system was designed for use by providers to facilitate access to intellectual disabilities services. IDOLS allows providers, including Community Service Boards and Behavioral Health Authorities, a more efficient method of transacting business regarding the Waiver Wait List, Slot Assignment, and service authorization for necessary waiver services.

Because IDOLS is a web-based system, providers using IDOLS will no longer be required to use DMAS paper forms for many waiver-related processes. As of the date of this Memorandum, ID waiver service providers may begin using IDOLS web-based forms in lieu of the forms listed below.
