The following pages are the judicial application form in .pdf format. You can fill out this application online and print it directly from your computer. After you print out the application, please sign it in front of a notary, and send one single-sided copy to the Council with your photos. When filling out this form, please remember:

- The form can be filled out online and printed, and the **Adobe Reader program may now** allow you to save your copy as a file on your computer. However, you may not be able to save your work due to software incompatibility. If you close Adobe Reader or the application form, all the information you have entered may not be saved. It is very important that you print your application before you close. If you print each page as you complete it you will not have to reenter data if the program is accidentally closed and your information is not saved.
- There are three types of fields on the application: single line text fields, multi-line boxes and check boxes. The text fields and the multi-line boxes limit the number of characters that can be entered. If you need more space, please attach a separate labeled sheet to your application.

A copy of this statement will be scanned and posted on the Council's website after the application deadline. Unless you object, we will post your picture as well. In its bar survey, the Council will invite attorneys to review the information if they wish to become more familiar with your background and experience.
- 4. This application constitutes a public record within the meaning of AS 09.25.110 and AS 39.25.080. All information, except that specifically denoted as confidential herein (Section II), is available for public inspection. Also, the Council forwards each nominee's application to the governor, including the confidential sections.
- 5. The Judicial Council asks that each applicant review the Code of Judicial Conduct (Alaska Rules of Court). Please note that Ethics Opinion 85-1 of the Alaska Bar Association provides that the proscription of Canon 5 (formerly 7) of the Code of Judicial Conduct specifically applies to candidates for appointment to judicial office under Alaska's merit selection plan.
