**Purpose of report** 

To seek Cabinet Member approval for the release of Capital Funds.

Contribution to our plans and strategies

The Hillingdon Local Plan: Part One – Strategic Policies Hillingdon's Sustainable Community Strategy 2011 London Borough of Hillingdon Local Implementation Plan 2011.

**Financial Cost** 

The report seeks the release of £907k from the 2014/15 TfL LIP for Principal Road Renewal Programme within Hillingdon's highways network as detailed in this report.

The project manager is John Fern.

The works will commence upon release of the funds and are due for completion by March 2015.

#### RECOMMENDATIONS

That the Leader of the Council and the Cabinet Member for Finance, Property and Business Services agree to the following capital and revenue release request of £907k from the Principal Roads Renewal Programme funded from the 2014/15 Transport for London (TfL) Local implementation Plan (LIP) programme. (Appendix A)

PLEASE NOTE: A duplicate of Appendix A is attached to the YELLOW decision request form so that the Cabinet Member can indicate for each scheme, whether project approval is granted, sign it and return it to Democratic Services for publication along with the standard yellow form.

#### **INFORMATION**

#### Reasons for recommendation

The proposal fully complies with and supports the intentions of the 2014/15 LIP Principal Road Renewal grant allocation announcement made by TfL in January 2014. The recommendation will enable Hillingdon to sustain its past LIP performance which is critically important to secure future funding to the Borough. Any undue delay in implementation, or failure to meet agreed performance measures, could adversely influence future TfL funding opportunities for the Council.

In discussion with the Cabinet Member for Planning, Transportation and Recycling the present list of projects has been agreed. All costs will be borne in their entirety by TfL.

#### Alternative options considered

The proposal could be deferred for consideration to a future programme, however as this funding is a 2014/15 allocation any under spend would be a lost opportunity to renew principal roads at TfL's expense.

Hillingdon could decide to delay or refuse the acceptance and delivery of the 2014/15 TfL budget. Such a decision would adversely affect the delivery of the TfL approved LIP Programme and the contribution these make to the implementation of the Council's Sustainable Community Strategy.

Delivery of the project is to be funded by LIP, Principal Roads Renewal budgets for highway maintenance. The implementation of these funds are time critical, as the money made available by TfL is for the 2014/15 financial year only and cannot be carried forward. Delay to any authorisation may jeopardise the completion of these schemes and receipt of funding as adequate time is needed for preparatory work and implementation.

#### **Supporting information**

TfL have announced Hillingdon's LIP grant settlement for 2014/15 as follows:

In December 2013 there was confirmation of an allocation of:

- £2,716k for Corridors, Neighbourhoods and Supporting Measures
- £907k for Principal Road Renewal
- £681k for Hayes Town Centre
- £106k for Borough Cycling Programme

Additionally there are following sums to be added to this budget

£800k carried forward from the TfL 2013/14 allocation

PART 1 – MEMBERS, PUBLIC & PRESS

#### £129k S106 funding

The above allocations total to £5,339k and this is a combination of capital and revenue funding.

Hillingdon's LIP grant settlement for 2014/15 was based on its Local Implementation Delivery Plan 2014 – 2017, which was approved for final submission to TfL by Cabinet in September 2013. It sets out how the Council proposes to secure transport improvements within the Borough, reflecting both the Borough's transportation priorities and the Mayor's Transport Strategy (MTS). It was developed in light of the resources to be made available by the Mayor of London, much of which is supported by national transportation guidance and programmes. The Plan provides details on transport projects, proposals and programmes to 2014. It also takes full account of TfL's current guidelines and the funding programme.

#### Scope of Works - Principal Road Renewal 2014/15

Funding has been secured to deliver highways renewal and improvement schemes on:

- A4180 High Street, Ruislip from Kingsend to Ickenham Road;
- A437 North Hyde Road, Botwell from Dallas Terrace to Borough boundary;
- A408 Stockley Road, West Drayton, Lavender Rise junction; and
- A437 Dawley Road, Botwell, from Swallowfield Rd to Kestrel Way.

Funding is allocated based on the results of annual London Principal Road Network Condition Surveys carried out using SCANNER and DVI technologies. The surveys are undertaken by Transport for London on behalf of the Borough. Schemes identified were approved by the Leader of the Council in October 2013, prior to submission to TfL.

#### **EFFECT ON RESIDENTS, SERVICE USERS & COMMUNITIES**

#### What will be the effect of the recommendation

The various projects support the aims and objectives of the Council as set out in the LIP and in line with the Mayor of London's transport and highways investment criteria. The funding will enable implementation of key schemes and transport projects, which will lead to improved transport provision in the borough for the benefit of residents and ride quality experienced by road users.

#### **Financial Implications**

# (Total Budget £5,339k, previously released £800k (2013-14 programme), Release Requested £907k) – Appendix A

The 2014/15 MTFF Capital Programme agreed by Council on 13<sup>th</sup> February 2014 includes an estimated capital budget provision of £4,058k. This comprises £3,129k TfL grant in respect of 2014/15 programme, £800k from 2013/14 programme that has been re-phased into 2014/15 in the MTFF and £129k Section 106 contribution towards the programme.

TfL have agreed an allocation on Principal Road Renewal of £907k, which is £4k higher than the estimate included in the MTFF programme and is included in the table below. The allocation of £907k is confirmed on the Borough portal.

The TfL Programme as detailed in this document shows the Council's Transportation programme aspirations for 2014/15. This is currently estimated to be £4,410k (Capital & Revenue) based on the latest TfL notification. In addition £800k from the 2013/14 programme has been re-phased into 2014/15 and there are £129k S106 contributions.

It is anticipated that as in previous years, further TfL funding will become available for the course of the financial year. Any future additional funding will be reported in subsequent Capital Release Reports.

The funds which are the subject of this capital release request are part of a sum which TfL has allocated to the London Borough of Hillingdon, which the Council can make claims for in arrears. There are no implications for the Council's budgets arising from this report.

The table below shows the distribution of capital and revenue between the scheme programmes.

#### **CORPORATE IMPLICATIONS**

#### **Corporate Property & Construction Comments**

There are no property implications arising from the recommendation set out in this report.

#### **Corporate Finance Comments**

Corporate Finance has reviewed this report and concurs with the budgetary position set out above, noting that the Transport for London Local Improvement Plan is fully funded by external contributions. As an externally funded budget there are no direct financial implications for the Council's General Fund from this programme.

#### **Legal Comments**

Decisions on the release of monies for all capital projects are delegated to the Leader jointly with the Cabinet Member for Finance, Property and Business Services. This is contained at Article 7.08 paragraph (e) 12 of the Cabinet Scheme of Delegations of the Council Constitution.

Under the Provisions of section 111 of the Local Government Act 1972 a local authority has the power to do anything which is calculated to facilitate, or is conducive or incidental to the discharge of any of their functions. The work carried out in accordance within this Capital Programme would fall within the range of activities permitted by Section 111.

The recommendation therefore falls within the Leader's and the Cabinet Member for Finance, Property and Business Services individual delegations.

All goods, works or services that are the subject of this capital release request shall be procured and awarded, in accordance with the Council's Procurement & Contract Standing Orders – Schedule H.

#### CAPITAL RELEASE PROTOCOL

The release of all capital funds held by the Council is to be made by a formal decision (by the Leader and Cabinet Member for Finance, Property and Business Services).

No expenditure can be placed or committed by officers until this formal approval is given by Democratic Services.

Release of funds must be for identified projects only and strictly not for general release of funds for projects to be identified at a later date. No block releases of capital will be allowed, except if authorised by the Leader of the Council in advance to Central Finance.

The release of funds will only be made if previous Council, Cabinet or Cabinet Member agreement has been given to the project and only if there is an approved budget.

No contract should be signed until clearance is given to the release of capital funds by way of the formal decision-making process detailed below.
