

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:30 a.m. on **THURSDAY, NOVEMBER 6, 2008**, upon the application of **COMSTOCK OIL & GAS-LOUISIANA, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Jeter Zone**, in the Logansport Field, DeSoto Parish, Louisiana.

1. To designate Comstock Oil & Gas-Louisiana, LLC as unit operator of the existing drilling and production units designated as JETER SU59 and JETER SU60.
2. To permit the Applicant to designate and utilize its Williamette No. 1 Well and T.G. Chandler No. 2 Well, as the substitute unit well for JETER SU59 and the unit well for JETER SU60, respectively, in exception to the well spacing provisions of Office of Conservation Order No. 28-C-32, effective May 14, 1985.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the existing drilling and production units designated as JETER SU59 and JETER SU60, with allocation of production from the tracts within each of such units to be on the basis of surface acreage.
4. To consider such other matters as may be pertinent.

The Jeter Zone was fully defined in Order No. 28-C, effective February 20, 1942.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
