## REALTREE OUTFITTERS ULTIMATE RACE DAY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASES DO NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON NUMBER OF ENTRIES RECEIVED. VOID WHERE PROHIBITED.

- 1. Promotion and Sponsor: Participation in the Realtree Outfitters Ultimate Race Day Sweepstakes (the "Promotion") constitutes Entrant's full and unconditional agreement to these Official Rules. Entrant is free to disclaim any prize and status as Entrant (as defined below) and as a result will not be eligible to receive any prize.
