Documentation Requirements for Overseas Residence

If you are applying for registration and you have resided outside of Ireland and/or Northern Ireland for a total of three years or more, after the age of 18, you are required to provide certified copies of police clearance documents from all jurisdictions/states of previous residence, referring to the time spent in each jurisdiction/state. The Teaching Council only accepts police clearance documents which cover the entire period of residence in other jurisdictions/states. The Garda Central Vetting Unit currently undertakes vetting on addresses in Ireland and Northern Ireland only.
