William Dombi, Esg. Vice President for Law

Bill Dombi specializes in legal, legislative, and regulatory advocacy on behalf of patients and providers of home health and hospice care. With over 30 years of experience in health care law and policy, Bill has been involved in virtually all legislative and regulatory efforts affecting home care and hospice since 1975, including the expansion of the Medicare home health benefit in 1980, the formation of the hospice benefit in 1983, the institution on Medicare PPS for home health in 2000, and the massive health care reform legislation in 2010.

With litigation, Bill was lead counsel in the landmark lawsuit that reformed the Medicare home health services benefit, challenges to HMO home care cutbacks for high-tech home care patients, lawsuits against Medicaid programs for inadequate payment rates, a nationwide class action against then-HCFA for its failure to enforce the federal HMO Act, litigation directed against the "Interim Payment System" for the Medicare home health benefit, and a lawsuit addressing the so-called Medicare "case mix creep adjustments" in 2008-2010.

Bill has also been instrumental in national efforts by the Council for Medicaid Home Care and their initiatives to protect the stability of providers delivering services and access to care for Medicaid beneficiaries.

In 2010, HCP presented Bill with the prestigious Richard Z. Steinhaus Award for his outstanding contributions and years of service on behalf of the home care industry.


