Highlights of the WAAIME

Executive Committee meeting

Dear WAAIMES — We in the East are hoping that this winter is over. Best wishes for a happy spring to all of you. As the new chair of the executive committee, I have summarized the annual meeting to apprise you of our activities.

Change in investment bankers

WAAIME made a change in investment bankers from Hirtle Callaghan to UBS. It was found that SME's portfolio had a return of 13.68 percent with UBS in 2013, and the WAAIME portfolio had only an 8.47 percent return that same year. An additional benefit of the change for SME and WAAIME was a reduction in fees due to almost doubling the investment amount managed by UBS. The Executive Committee also approved an investment policy based on SME's policy. This was approved by the SME Board of Directors at its meeting.

Section Grant Program

SME approved our proposed Section Grant Program. Ten sections applied for funding for special projects. These proposals were very diversified and included the support of elementary school projects and earth-science equipment purchases for rural schools, as well as equipment and programs for university students. The requests were all excel-

served on the executive committees three SME divisions: Coal & Energy, Mining & Exploration and Environmental. She was instrumental in founding the SME Student Mentor program and was president of SME in 2005.

MARIA CECILIA MARTINEZ MOYA, a vice president with the Peru-Lima Section, has replaced Veronica Yovane Brahm as the International Representative to the WAAIME Executive Board. She will serve the last two years of Veronica's term.

lent, so the executive committee decided to award each of the 10 sections \$2,000 to assist them in completing their projects. The executive committee requires feedback on this program and will review the program's success at the midyear meeting.

Founders Award

SME approved our proposed Founder's Award. The particulars are included in this newsletter with the hope that the first award can be presented at the 2015 annual meeting. Please review the criteria to see if there is a worthy candidate within your section or a member-at-large.

Approved disbursements

The executive committee also approved disbursements to the SME Minerals Education Coalition program for \$5,000 and to the Colorado Mining Association's Total Concept of the Mining Industry program for \$3,000. The latter organization is planning to extend its reach by using the Internet to present its program to earth science teachers.

Scholarship applications

Approximately 136 scholarship applications were reviewed, which included about one-third graduate students, mostly Ph.D. candidates. The preliminary grant amount total is \$243,000. A new application is being designed for review at the midyear meeting. This will also include an interview procedure to standardize the interviews.

Investment portfolio

Our investment portfolio is currently about \$8.4 million with operating expenses of approximately \$60,000 or less. Grants to the international sections, section grants, awards and scholarships are other deductions.

Recommendation to join SME Foundation

A recommendation was presented by an SME ad hoc committee proposing that WAAIME join the SME Foundation Board instead of remaining a separate division. This proposal will be reviewed by the executive committee.

Executive Committee changes

The Executive Committee had several changes in personnel, as Beth Price, Western Representative and chair, completed her three-year rotation and was replaced by Barbara Filas, the incoming Western Representative. Veronica Yovanne Brahm, International Representative, submitted her resignation so that Cecilia Martinez from Lima, Peru could be appointed as the new International Representative for the remaining two years of this term. Our thanks to Beth and Veronica, and welcome to Barbara and Cecilia. (Continued on page 4)

Founder's Award AIME News

WAAIME's announces the Founders Award guidelines

The Founders Award was established by WAAIME in 2014 to be awarded in 2015 and each year subsequently. It is presented to a person in recognition of her or his exemplary service to WAAIME and its goals. This award is designed to replace the WAAIME National Honorary Member program and to recognize those members who have contributed significantly to a local section, the national board or committee or to further the goals and purposes as set forth in WAAIME's incorporation. This award is funded by our founding section, Tri-State (NY-NJ-CT) and is given in honor of their many years of service and hard work to build the WAAIME fund that promotes the many industries that make up the original American Institute of Mining, Metallurgical, and Petroleum Engineers, and its member societies, SME, SPE, TMS and AIST.

Eligibility criteria for the award is as follows.

- The nominee must be a WAAIME member in good standing of at least five years.
- The nominee must not have been awarded National Honorary Member status.
- The nominee must be willing to accept the award in person at the annual meeting.
- All members, including members-at-large, may be considered subject to the above.
- Any nomination of a current member of the WAAIME Executive Committee will be considered active when the nominee has rotated off the executive committee.

Timeline

The award typically adheres to the following timeline:

- Call for nominations in the May newsletter.
- Nomination deadline July 1.
- Qualified nominations are forwarded to the executive committee July 15.
- Executive session at September midyear meeting completes voting.
- Recipient is notified in October.
- Award is presented at the SME Annual Meeting

Nominations

Nominations for the award should contain the following information:

- Completed nomination form including demographic and contact information for the nominee and the principle nominator.
- Up to five letters of support detailing the nominee's qualifications for the award (two-page maximum, each).
- Nominee's biography or résumé (two-page maximum).
- Nominee's experiences/history within WAAIME, including any positions held in the local section(s) and/or on the national board/committee.

All nominations submitted will be considered active nominations for a period of three years. Nominations must be submitted in accordance with the guidelines provided herein and on the accompanying nomination form.

Administration

This award is administered by the WAAIME Executive Committee. The award committee consists of the three members of the WAAIME Executive Committee and can include up to two additional WAAIME members at the discretion of the executive chair. All voting will be completed during an executive session at the midyear meeting. Recipients of the award shall be selected by majority vote of the committee with notification to the SME board. The award need not be presented in any given year if a suitable candidate cannot be selected by the majority.

Award and its presentation

The award consists of a 14-karat gold charm/pendant designed by the Mexico-DF Section of WAAIME and engraved with the recipient's name and date of presentation. The recipient will also be able to designate where a \$500 donation may be given, for example, to a section, to a university program or student section, or to any other earth science-based entity or program. The charm and \$500 bequest are fully funded by the Tri-State Founder's Fund and WAAIME. The award will be presented at the SME Annual Meeting
