




ELA/Literacy and Mathematics, Grades 3-8 and High School



## State Governance and Participation

- Consortium led by state K-12 and higher education representatives. All major decisions are subject to state vote.
- Executive committee oversees assessment development and consortium funding.
  - Deb Sigman, CDE Deputy Superintendent of Public Instruction, District, School, and Innovation Branch (Co-Chair)
  - Beverly Young, Assistant Vice Chancellor, California State University
- Standing advisory panels of experts on various topics (e.g., technical advisory committee, English learner advisory committee)
- Workgroups with over 80 staff from member states and higher education institutions which help design the system.





### **Smarter Balanced Item Types**




## Initial Achievement Level Descriptors (ALDs)

- Articulate the knowledge and skills expected of students at different levels of performance.
- Developed at the beginning of test development so expectations for student performance can guide test development.
- Approved by governing states in March 2013
- Available on the Smarter Balanced Web page at <u>http://www.smarterbalanced.org/achievementlev</u> <u>el-descriptors-and-college-readiness</u>




## Initial Achievement Level Descriptors (ALDs)

- Policy ALDs: guide test development and conceptualization
- Range ALDs: guide item writing
- Threshold ALDs: guide cut score recommendation and standard setting
- Reporting ALDs: guide test score interpretation (to be developed after pilot and field testing and standard setting)



### **Preliminary Test Blueprints**

- Provide clear test development specifications, including:
  - Content, number of items, item types, score points, and depth of knowledge for items
- Estimated student testing time per subject is 2½ to 4 hours
- Number of items per test varies
- One performance tasks per test



### **Preliminary Test Blueprints**

- Approved by governing states in November 2012
- Considered preliminary until after review of the data gathered from the pilot and field tests








## Support for Under-Represented Students

- Accessibility is a core principle of the Smarter Balanced development process. The goal is to ensure equity of access for all students and provide valid measures of student achievement.
- Accessibility and Accommodations Policy
   Framework (to be released by June 2013 for public review and comment)
  - Will provide guidance on how assessment accessibility needs of English learners and students with disabilities will be met through item design and delivery methods for a digital environment as well as by local staff.


## **A&A Policy Framework**Draft Conceptual Model

## **Spring 2013 Pilot Test**

#### For all students:


- Universal digital tools (all items)
  - Pausing; variable font size; highlighting; marking for review; answer eliminator; expandable passages; tab-enter navigation; calculator\* (on items that are not testing fluency with math operations)
- Universal digital tools (ELA performance tasks)
  - Bold, italics, underline; indent; cut, copy, paste; spell check; undo/redo

#### For students identified by LEA:

- Accommodations supports
  - Extended time, frequent breaks, quiet environment, font background color alternatives, print on request

#### For students identified by Smarter Balanced:

- Research forms (math 3, 7, 11 and ELA 4, 7, 11)
  - Full Spanish translation (math only); online Spanish glossaries (math only); online refreshable Braille; text to 19 speech; online English glossaries



### **Spring 2013 Pilot Test**

- February 20-May 24, 2013
- Grades 3-11 in English-language arts and mathematics
- Computer based
- Approximately 5,000 items to be tested
- No results will be released publicly



### **Spring 2013 Pilot Test**

- Over one million students are scheduled to participate (approximately 360,000 students from California)
- Over 1,400 California schools have confirmed participation.

#### **Practice Test**

- Formerly called the Volunteer Pilot Test
- Access will begin May 29, 2013
- Will be available to all schools, districts, parents, policymakers, and other stakeholders
- Access will continue until implementation of operational assessments




#### **Practice Test**

- Complete test forms will be used
  - One test form for each grade and content area
  - Will follow the test blueprints
- Accommodations
  - Text-to-speech
  - Item-level pop-up Spanish glossaries for construct-irrelevant terms (math only)
  - Braille
  - American Sign Language




### **Spring 2014 Field Test**

- Approximately 40,000 items to be tested
- Participation of 5-6 million students expected across member states
- Computer-adaptive component
- Smarter Balanced is exploring options for providing some level of results to participating schools




## Digital Library of Formative Assessment Tools and Practices

- An interactive professional development tool to guide teachers in identifying and using the best resources for their needs.
- Will include resources such as:
  - Best practices for classroom instruction across all grade levels
  - Demonstration videos
  - Research-based formative assessment tools and practices
  - Sample summative/interim test items



## Digital Library of Formative Assessment Tools and Practices

- Upcoming opportunity for teacher involvement! Each Smarter Balanced member state to form a State Network of Educators (SNE) to review proposed resources for inclusion in the digital library.
  - CDE will recruit approximately 150 California educators for the SNE
  - Recruitment expected to begin in May 2013
- To be launched in spring 2014


