7 EXPLANATION OF CORRECTION

This report is being corrected due to an improper date which was caused by the last change in the filing software. The report Period Covered and three (3) entries in the Expenditures contain the year 2020. These should have been 2005 and have been corrected in this Corrected Filing. This situation was brought to my attention during a discussion with the Ethics electronic filing department on another issue. I believe the original report submitted substantially complies with applicable law. This coupled with the software program change which caused the error should be grounds for a ruling of no penalties due to filing this corrected report after the filing date. The problem in the software is as follows. In the prior software program you input the year as a four digit number. For example 2005 was entered as 2005. I assume this was due to the Y-2-K problems with two digit dates. However the new revision of the software request at Two (2) digit input. For example 2005 would be 05. The problem is that if you enter 2005 the software records it as 2020 because it keys on the first two digits. And that is why my initial report had the year 2005 recorded as 2020 throughout the report. This was not noted by your report checks or my visual review of the report when it was submitted. This has been corrected and I have reprogrammed my skills at entering dates into the electronic reports. I request that you accept this corrected report and that any penalties due to late submission be waived.
